WHEREAS, the severity and frequency of flooding in the Snoqualmie River Basin is a particular concern, and

WHEREAS, involvement of citizens is an important way to incorporate community needs and priorities into the plan;

NOW, THEREFORE, BE IT MOVED by the Council of King County:

- A. There is established a fourteen-member Snoqualmie River Basin Citizen Advisory Committee, composed of the individuals listed in attachment A.

- C. The committee will be advisory to staff. Consensus between staff and the advisory committee is a goal of the plan process.
