A MOTION authorizing the county executive to make a grant application for funds in the approximate amount of \$8,319 in 1991 to support development of data gathering and intervention responses related to drowning incidents and deaths in adolescents in King County.

WHEREAS, the Washington State Department of Health is authorized to make grants of funds from the Injury Prevention Program to support projects designed to reduce the incidence of injury to the general population, and

WHEREAS, research has shown that drowning within the adolescent age group is a serious public health and social problem within King County and,

WHEREAS, gaps exist in reporting of submersions and drownings within King County, and

WHEREAS, the public health program directed toward drowning prevention, particularly among adolescents would be enhanced through a grant by Department of Health funds;

A. The King County executive is hereby authorized to make application for funds in the amount of \$8,319 to the Washington State Department of Health to partially support the development of a drowning data gathering system and a drowning prevention program targeted toward King County adolescents.

Among pediatric (0-19 years of age) victims of drownings and near drownings in King County, the highest incidence occurs in the 15-19 year age group (41) (43.6%). The highest levels of mortality occur predominantly in lakes and rivers. The 15-19 year age group also has the highest proportion of drownings in which blood alcohol levels were detected in the victims (25%).

Among all drownings, lake and river victims had the highest incidence, mortality, and case fatality rate. $8\,16\,5$

Drownings have decreased significantly since King County Board of Health Regulations for swimming pool safety became effective in 1982. The regulations imposed requirements for fencing, pool markings, supervision and safety equipment at regulated pools.

The above data demonstrates a sharp contrast between regulated facility swimming and unregulated swimming settings.

While the incidence of drowning misadventure among 15-19 year olds is the highest among pediatrics, data of the contributing factors are not clear. Reversal in the numbers of 15-19 year old drownings is not likely without devoting study to the causes with the aim of remediation.

Therefore, using the resources afforded by the mini-grant, we propose to: 8165

- A. Accumulate new data and review existing data related to drowning and near drowning incidents in King County, emphasizing 15-19 year olds and applying the data to development of an intervention program. This phase will be six months and on-going.
- B. Develop age group and site specific intervention strategies, directed toward 15-19 year olds using unprotected lakes and rivers for recreational swimming and adventure settings.

This project will be assigned to Mr. A.A. Gomez, Senior Environmental Health Specialist, who has twelve years experience in water safety, public health pool and spa sanitation, as well as research and publication in the field. In addition, Mr. Gomez has extensive association with persons involved in all aspects of recreational water sanitation and injury prevention. Mr. Gomez and Mr. Anthony Bossart, Chemical and Physical Hazards Program Supervisor, will attend the required training session in injury prevention.


Additional intra-departmental support will be provided by staff in the Environmental Health Division, Personal Health Services staff and Health education.
