Add to Exhibit I.2 (page 4) the following language:

## "SEXUAL PREDATOR CASES"

"The Agency shall be reimbursed by OPD from funds provided by the State of Washington for cases filed under the Civil Commitment section of the Criminal Offenders Sexual Violence Act, Chapter 3, Part X, Laws of 1990, and assigned to the Agency by the County at the hourly rate of \$44.16 for 1990. Agency costs shall be based on submission of regular monthly expenditure reports as required by this Contract and submission of a billing to OPD containing a statement of the names and the number of hours spent by each attorney working on the case during the month. OPD shall submit to the State of Washington a billing including the information provided by the Agency within ten (10) days of receipt of the Agency billing. OPD shall remit funds received from the State of Washington to the Agency within ten (10) days of receipt.

Reimbursement to the Agency shall be made subject to such other conditions as may be stated in any interagency agreement between the County and the State of Washington Department of Social and Health Services from the effective date of such agreement, and shall be incorporated into this Contract by written amendment as necessary. OPD has funding for reimbursement of up to 462 attorney hours in 1990."
