2 A MOTION authorizing the King County executive to
3 submit an application for funding and supporting
4 the project recommendations of the executive for
the United States Department of Housing and Urban
Development 1991 Emergency Shelter Grants Program.

5 WHEREAS, housing the homeless is a pressing community and human
6 services need, and

7 WHEREAS, emergency shelter and services are critical to homeless
8 families working toward self-sufficiency, and

9 WHEREAS, eligible activities for Emergency Shelter Grants Program
10 (ESGP) funds include homeless prevention assistance, supportive services,
11 rehabilitation, and operating costs associated with emergency shelter,
12 and

13 WHEREAS, King County will receive an entitlement of \$111,000 of
14 ESGP funding from the United States Department of Housing and Urban Develop-
15 ment, and

16 WHEREAS, the Comprehensive Homeless Assistance Plan contains strate-
17 gies to match the needs of the homeless in King County with the resources
18 available, and

19 WHEREAS, a request for proposal process was conducted in December 1990,
20 and

21 WHEREAS, proposals were received and evaluated based on King County
22 funding policies and ESGP rules, and

23 WHEREAS, the King County council has appropriated funds for ESGP
24 in Budget Ordinance 9720;

1 NOW, THEREFORE, BE IT MOVED by the Council of King County:

2 The recommendations of the King County executive for emergency shelter
3 projects as specified in Attachments A and B are supported.

4 BE IT FURTHER MOVED,

5 The King County executive is hereby authorized to submit a 1991
6 program application to the United States Department of Housing and Urban
7 Development for the ESGP.

8 The King County executive is authorized to enter into contracts
9 with agencies to provide 1991 ESGP funds for recommended projects.

| (1) Friends of Youth Shelter
Operating Support | Food, phone, utilities, maintenance and insurance to operate two youth shelters and one transitional home for homeless teen mothers. |
| (2) Auburn Youth Services Youth
Shelter Operating Support | Agency insurance, telephone, utilities, insurance, and fuel for a van to operate the youth shelter. |
| (3) South King County Multi-
Service Center Emergency
Shelter Support | Eviction prevention and utilities, insurance and maintenance to operate 15 emergency shelter units. |
| (4) Fremont Public Association
Emergency Shelter Program | Lease motel units for emergency housing and support services for single and two-parent homeless families. |
| (5) YWCA Shelter Program | Maintenance and operation, homeless prevention activities and rehabilitation costs of three emergency shelters. |
| (6) NW AIDS Foundation Emergency
Shelter Voucher Program | Vouchers for one or two units which serve as emergency shelter for homeless persons diagnosed with Class IV AIDS. |
| (7) Multi-Service Center of North/
East King County Voucher
and Eviction Prevention | Eviction prevention and lease of one motel unit for shelter for homeless families. |
| (8) Eastside Domestic Violence
Operating Support | Insurance, telephone and utilities in support of operations of an emergency program (safe homes) for abused women and their children. |
