3 ment Block Grant Consortium Policy Plan, including the  
4 administrative setaside, and the 1992 Local Program  
5 Policies for the Pass-through Cities funds and for the  
6 County and Small Cities funds, including the King County  
7 regional earmarks for 1992.

8 WHEREAS, King County is a member of the King County Community Development  
9 Block Grant Consortium, and

10 WHEREAS, King County as the official applicant is responsible to the  
11 federal government for all activities undertaken in the King County Consortium  
12 with Community Development Block Grant funds, and

13 WHEREAS, federal Community Development Block Grant legislation requires  
14 King County to adopt an annual community development plan to guide the use  
15 of Community Development Block Grant funds and identify community development  
16 and housing needs, and

17 WHEREAS, the 1992 King County Community Development Block Grant Consor-  
18 tium Policy Plan (hereinafter referred to as the 1992 CDBG Consortium Policy  
19 Plan) meets the federal Community Development Block Grant requirements for  
20 an annual plan for the year January 1, 1992 to December 31, 1992, and

21 WHEREAS, King County Consortium members have participated in the develop-  
22 ment of the 1992 CDBG Consortium Policy Plan through review and comment,  
23 and

24 WHEREAS, the Consortium's Joint Policy Committee endorsed the 1992  
25 CDBG Consortium Policy Plan, including the administrative setaside;

26 NOW, THEREFORE, BE IT MOVED by the Council of King County:

27 A. The attached 1992 King County Community Development Block Grant  
28 Consortium Policy Plan including the administrative setaside, and the 1992  
29 Local Program Policies for the Pass-through Cities and for the County and  
30 Small Cities fund, including the regional earmarks, are hereby adopted to  
31 guide the planning and development of the 1992 Community Development Block  
32 Grant Program.
