5 A MOTION to set the date for a hearing upon the maintenance
6 assessment roll for Road Improvement District No. 123 for a
7 street light on 114th Avenue Southeast.

8 WHEREAS, King County Ordinance No. 9840 created King County Road Improvement District
9 No.123 for maintaining, energizing and operating a street light on 114th Avenue Southeast and adjacent
10 to the plat of Tudor Square Division No. 2, and

11 WHEREAS, the improvement has been completed and the cost is now known, and

12 WHEREAS, King County Ordinance No. 9840 directed the director of the department of public works
13 to prepare and file with the clerk of the council, a maintenance assessment roll for the maintenance
14 assessment to be levied against the property included in Road Improvement District No. 123, and

15 WHEREAS, the maintenance roll has been prepared and filed with the clerk of the King County
16 council:

17 NOW, THEREFORE, BE IT MOVED by the Council of King County:

18 A. Pursuant to the provisions of R.C.W.36.88.090, the hearing upon the maintenance assessment
19 roll for King County Road Improvement District No. 123 shall be scheduled for

20 September 23, 1991, at 9:30 a.m.

21 B. The King County council will sit as a board of equalization for the purpose of considering
22 aforesaid assessment roll at aforesaid hearing or hearings and will consider such objections as are made
23 thereto or any part thereof, and will correct, revise, raise, lower, change or modify said roll or any part
24 thereof, or set aside said roll in order that such assessments be made de novo as to such body shall
25 appear just and equitable, and then proceed to confirm the same by ordinance.

26 C. The clerk of the King County council is hereby directed to give notice of hearing upon said roll to
27 all owners or reputed owners of the property whose name appears thereon by mailing a notice thereof at
28 least fifteen days before the date fixed for the hearing to such owners or reputed owners at the address
29 of such owner as shown on the tax rolls of the King County office of finance; in addition thereto, such
30 notices shall be published at least two (2) times in a newspaper of general circulation in the county if the
31 paper is published weekly or five (5) times if the paper is published daily.

Such notices shall specify the time and place of the hearing on said roll and shall notify all persons who may desire to object thereto to make such objections in writing and to file same with the clerk of the council at or prior to the date fixed for said hearing.
