MOTION NO. 8970

A MOTION authorizing applications for funding Regional Projects from the Regional Conservation Futures 1993 Bond Acquisition Program.

WHEREAS, the Council has adopted Ordinance 10750, which establishes a Regional Conservation Futures Acquisition Program to acquire land for a system of public open spaces necessary for the health, welfare, benefit, and safety of the residents of King County, and

WHEREAS, \$15 million has been earmarked from the Regional Conservation Futures Acquisition Program for projects of extraordinary regional significance, and

WHEREAS, the following described properties are deemed to be high priority acquisitions of King county and will be included in the King County Comprehensive parks, Recreation, and Open Space Plan when adopted, and

WHEREAS, the following described properties are believed to represent acquisitions that best meet the criteria for allocating funds for regional projects as established in Attachment A of Ordinance 10750, and

WHEREAS, the deadline for submitting applications for funding consideration is April 21, 1993;

NOW, THEREFORE, BE IT MOVED by the Council of King County:

The county executive is hereby authorized to apply for acquisition of the following properties:

Waterways 2000 \$2.0 Million

Funding to implement a model riparian corridor system protection program to include purchase and less-than-fee protection of habitat systems along King County stream corridors. Systems to be considered shall include but not be limited to upper Bear Creek/Paradise Lake, Issaquah Creek, lower Soos Creek and their tributaries, lower May Creek, the main stem of the Green River, and the Snoqualmie System and their tributaries.

1 Cedar River Greenway System \$2.0 Million
 2 Acquisition of selected properties and other habitat protection
 3 along the Cedar River Greenway and Trail System, between Renton
 4 and Landsburg.

5 Cougar Mountain Regional Wildland Park Additions \$7.0 Million
 6 Acquisition of three properties adjacent to Cougar Mountain,
 7 totaling 669 acres.

8 China Creek headwaters 119 acres

9 Section #30/East Village 450 acres

10 Cougar Ridge 100 acres

11 Crisp Creek Watershed \$1.5 Million

12 Acquisition and habitat protection of the headwaters of this
 13 tributary of the Green River.

14 Marymoor Park/Sammamish River Addition \$2.5 Million

15 Acquisition of approximately 60 acres adjacent to Marymoor Park
 16 and the Sammamish River.

17 Maury Island Marine Park \$2.0 Million

18 Acquisition of approximately 150 acres of saltwater shoreline
 19 along the eastern shore of Maury Island

20 Moss Lake Addition \$1.5 Million

21 Acquisition of 108 acres adjacent to the existing wetland.


22 Rattlesnake Ridge \$2.0 Million

23 Acquisition of 633 acres of DNR-owned property on the East
 24 Sammamish Plateau.
