3 Development Block Grant Consortium Policy Plan,  
4 including the administrative setaside, and the 1994  
5 Local Program Policies for the Pass-through Cities  
6 funds and for the County and Small Cities funds,  
7 including the King County regional earmarks for 1994.

8 WHEREAS, King County is a member of the King County Community Develop-  
9 ment Block Grant Consortium, and

10 WHEREAS, King County as the official applicant is responsible to the  
11 federal government for all activities undertaken in the King County Consortium  
12 with Community Development Block Grant funds, and

13 WHEREAS, federal Community Development Block Grant legislation requires  
14 King County to adopt an annual community development plan to guide the use of  
15 Community Development Block Grant funds and identify community development and  
16 housing needs, and

17 WHEREAS, the 1994 King County Community Development Block Grant Consor-  
18 tium Policy Plan (hereinafter referred to as the 1994 CDBG Policy Plan) meets  
19 the federal Community Development Block Grant requirements for an annual plan  
20 for the year January 1, 1994 to December 31, 1994, and

21 WHEREAS, King County Consortium members have participated in the devel-  
22 opment of the 1994 CDBG Policy Plan through review and comment, and

23 WHEREAS, the Consortium's Joint Policy Committee endorsed the 1994 CDBG  
24 Policy Plan, including the administrative setaside;

25 NOW, THEREFORE, BE IT MOVED by the Council of King County:


26 A. The attached 1994 King County Community Development Block Grant


