A MOTION approving projects for the King County Cultural Facilities, Cultural Enhancement and Opportunity Grant Programs, in accordance with Ordinance 10189.

WHEREAS, The King County arts commission and landmarks and heritage commission are authorized by Ordinance 10189 to administer projects in the education and cultural development fund, and

WHEREAS, the King County cultural resources division received 165 applications requesting \$13,357,641 from the 1992 Cultural Facilities, Cultural Enhancement, and Opportunity Grant programs, and

WHEREAS, five review panels of arts and heritage professionals, community representatives and commission representatives reviewed the applications and made recommendations to the King County arts commission and landmarks and heritage commission, and

WHEREAS, the King County arts commission and the King County landmarks and heritage commission approved the review panels' recommendations, and

WHEREAS, the recommendations for arts and heritage project funding adhere to the guidelines and the financial plan policies approved by the King County council in Motion 8797, and

WHEREAS, the financial plan included as Attachment A, has been revised to indicate actual hotel/motel tax revenue for 1992 and projected revenue consistent with assumptions made in the 1993 adopted budget, and

WHEREAS, the financial plan and Proposed Ordinances 93-291, 93-292, and 93-472 support funding for the Cultural Facilities program, Arts Capital


1 projects, Small Arts Capital projects, and Heritage programs.

3 The executive is hereby authorized to allocate \$3,505,849 for arts and
4 heritage projects as listed in Attachment B for Cultural Facilities Program art
5 projects; Attachment C for Cultural Facilities Program heritage projects;
6 Attachment D for Cultural Enhancement projects; and Attachment E for
7 Opportunity Grant projects.
