

MOTION NO 9211

2 A MOTION authorizing the Executive to submit an
3 application for 1993-1995 Washington Department of
4 Community Development Growth Management Act grant
5 funds and authorizing the Executive to execute
6 agreements with the Washington Department of Community
7 Development and municipal jurisdictions for the
8 distribution of grant funds.

9 WHEREAS, the State Legislature has appropriated grant funds to assist
10 local jurisdictions in implementing the requirements of the Growth Management
11 Act, and

12 WHEREAS, King County jurisdictions as a region will receive \$2,557,411 in
13 grant funds for the 1993-1995 biennium, and

14 WHEREAS, 60% of the county's general purpose governments representing 75%
15 of the population must agree to a grant distribution formula and a regional
16 work program in order to receive the grant funds, and

17 WHEREAS, upon Council adoption of Motions 8087, 8506 and 9006 King County
18 has executed interlocal agreements with local jurisdictions to distribute
19 grant funds for the past three years, and

20 WHEREAS, the Liaison Group, an interjurisdictional group of planning,
21 public works and finance officials and city administrators or managers from 23
22 cities have recommended the grant distribution plan, and

23 WHEREAS, King County and municipal jurisdictions are authorized under
24 RCW 39.34 to enter into interlocal agreements;

25 NOW, THEREFORE, BE IT MOVED by the Council of King County:

26 A. The King County executive is authorized to apply for State of Wash-
27 ington 1993-1995 Growth Management Act grant funds and execute resulting
28 agreements with the Washington Department of Community Development. The
29 application includes approval of the following:

30 1. Joint Regional Strategy - Countywide Planning Policies work

2. Grant Allocation Formula which is governed by the following provisions:

a. a total of \$490,000 is reserved to support regional efforts undertaken in the Countywide Planning Policies work program;

b. each jurisdiction receives a \$14,580 base plus per capita allocation;

c. jurisdictions which are partially within King County and an adjacent county will have their base amount adjusted based on the proportion of their population located within King County; and

d. unallocated funds shall be distributed according to the formula described above.

3. Designation of the Liaison Group and GMPC Staff Group to oversee the accomplishment of the Joint Regional Strategy.

4. Designation of King County as the fiscal agent for the purpose of submitting the King County regional application and receiving and distributing grant funds according to the approved allocation formula.

B. The King County executive is authorized to enter into interlocal agreements, substantially in the form of Attachment A, with participating jurisdictions for the purpose of distributing 1993-1995 State of Washington Growth Management Act grant funds.
