1. **PROJECT / ACTIVITY:**

The King County Regional Historic Preservation Initiative will include preparation of public information and technical assistance materials to promote landmark preservation (nomination, designation and protection) in King County cities now without any form of landmark protection. Direct services and support for landmark preservation will be provided for two King County cities (Federal Way and Carnation) in 1994. In addition to general landmark services, initiation of a survey and a landmark designation are expected within each city. [See Attachment 1]

2. TANGIBLE PRODUCTS:

Products will include 1) extensive public information and technical assistance materials 2) landmark preservation services to two cities, 3) strategic historic preservation plans for each city and for provision of preservation services to additional cities, and 4) applications for grants to support additional preservation services . Technical assistance materials, including a model ordinance and interlocal agreement, will be used to promoting landmark preservation services in King County cities now without any form of landmark preservation. Landmark preservation services will be provided for two King County cities (Federal Way and Carnation) in 1994. Services to each city will include distribution of informational materials, at least two public workshops, at least three training workshops for staff and/or a local review board, at least two public hearings on city preservation issues, creation of a computerized resource database, and updating of existing survey information. A landmark designation and completion of the initial stages of a comprehensive survey are also expected for each city.

Problem Statement

At present, only King County and 2 of its 31 cities have landmark preservation programs; historic properties go unprotected in the remainder of municipalities, many of which are small and unable to support an independent, professional city program. King County has a wellestablished program and currently provides technical assistance and support for projects and facilities to heritage organizations throughout the county. Unlike other types of heritage preservation, landmark preservation requires legal jurisdictional authority over historic properties. Thus interlocal agreements and additional support are necessary to enable King County to provide landmark preservation services within a municipality. King County is currently discussing interlocal agreements for preservation services with five cities in addition to Federal Way and Carnation.

Project Goals

The purpose of this project is to further consistent and comprehensive landmark preservation on a region-wide basis in King County. This project will extend landmark preservation services to two additional cities and serve as a model and incentive to the remainder.

Project Objectives

• Develop and distribute a comprehensive package of public information and technical assistance materials on local landmark preservation to cities, including a model landmark preservation ordinance and city-county interlocal agreement.

• Provide landmark preservation services to at least two cities (Federal Way and Carnation) by means of interlocal agreements.

• Prepare for and initiate historic resource surveys and landmark nominations in the two cities with interlocal agreements.

• Develop strategic preservation plans for two cities (Federal Way and Carnation), a strategic plan for providing preservation services to additional cities in King County, and grant requests to support planned preservation services.

• Use the materials, model agreements, strategic plan, and the successful precedent of two interlocal agreements to promote landmark preservation in other cities in the county.

King County Landmarks and Heritage Commission Hourly Contribution Valuation

By ordinance the King County Landmarks and Heritage Commission must include a minimum of three professionals in fields relevant to historic preservation. Lay members must have a demonstrated interest and experience in historic preservation. Current lay members are or have been active in local historic societies or historic museums for extended periods. At present, the Commission includes members whose time is valued at the following rates:
