MOTION NO. **9246**

1 A MOTION authorizing applications for  
2 funding assistance for outdoor  
3 recreation and habitat conservation  
4 projects to the Interagency Committee  
5 for Outdoor Recreation.

6 WHEREAS, King County has approved an "Open Space Plan" identifying  
7 trails, natural areas and greenbelts which are needed to develop a quality park  
8 and open space system, and

9 WHEREAS, the county is in the process of completing a comprehensive park  
10 and recreation plan, and

11 WHEREAS, under the provision of the Marine Recreation Land Act or the  
12 Washington Wildlife Recreation Program, state and federal funding assistance  
13 may be authorized for financing the acquisition of parks and habitat  
14 conservation areas and the construction of public outdoor recreational  
15 facilities;

16 NOW, THEREFORE BE IT MOVED by the King County Council:

17 A. The King County executive is hereby authorized to make formal  
18 application to the Interagency Committee for Outdoor Recreation for funding  
19 assistance through the 1995 grant cycle for the following projects:

Lake Sawyer	Acquire ≈54 Acres	NW of Black Diamond
Marymoor Addition	Acquire ≈70 Acres	Redmond
Innis Arden Reserve	Acquire ≈23 Acres	Shoreline
Snoqualmie Valley Trail	Development	Snoqualmie Valley

29 B. When further information is available regarding the 1995 funding  
30 cycle for Interagency Committee grants, the executive is requested to obtain  
31 approval from the Utilities and Natural Resources Committee before submitting  
32 grant applications for specific projects.

33 C. King County hereby certifies that, if a specific project grant is  
34 accepted, the county will fully support its grant match commitments.

1 D. Any property acquired with financial aid through the Interagency  
2 Committee for Outdoor Recreation shall be used as an outdoor recreation area or  
3 habitat conservation area and be retained in such use in perpetuity unless  
4 otherwise provided and agreed to by the King County Council, the Interagency  
5 Committee for Outdoor Recreation, and any affected federal agency.

6 E. This motion shall be part of the formal application to the  
7 Interagency Committee for Outdoor Recreation.

8 F. The office of open space has given adequate notification and  
9 opportunity for public input and published notices identifying affected flood  
10 plains and/or wetlands, if applicable.

11 G. King County hereby certifies that the county is owner of lands to be  
12 developed based on current knowledge and provides assurance there are no  
13 encumbrances on such lands which would restrict the recreation or habitat  
14 conservation use of the land as proposed in this application.
