A MOTION authorizing the King County Executive to enter into an interlocal agreement with the City of Lake Forest Park to define the terms and conditions for King County to continue to monitor residential recycling collection services in unincorporated areas annexed by Lake Forest Park from September 1, 1993 to December 31, 1996.

WHEREAS, the City of Lake Forest Park and King County have adopted the King County Comprehensive Solid Waste Management Plan which includes a 50 percent waste stream reduction goal by 1995, and

WHEREAS, the Plan establishes minimum levels of residential recycling services, and

WHEREAS, cities are responsible for ensuring the provision of the minimum level of services within their jurisdiction and the county is responsible for ensuring these services in unincorporated areas, and

WHEREAS, the City of Lake Forest Park has a contract for residential recycling collection services that is in effect until December 31, 1996 and the city is annexing areas not currently served through this contract, and

WHEREAS, King County monitors the recycling collection services of the certificated haulers in unincorporated King County pursuant to the requirements of King County Code (KCC) 10.18, and in conjunction with the Washington Utilities and Transportation Commission, and

WHEREAS, the City of Lake Forest Park wants to continue to have King County monitor residential recycling collection services in any areas annexed into the City from September 1, 1993 - December 31, 1996, and

WHEREAS, the City of Lake Forest Park will extend the areas served by their contract for residential recycling services after December 31, 1996 to include any areas annexed prior to that date, and

WHEREAS, King County will not monitor residential collection services after December 31, 1996.

NOW THEREFORE, BE IT MOVED by the Council of King County:

The King County executive is hereby authorized to enter into an agreement with the City of Lake Forest Park substantially the same as attached hereto as

1 Exhibit A to define the terms and conditions for King County to continue to  
2 monitor residential recycling collection services, pursuant to KCC 10.18, in  
3 those unincorporated areas annexed by Lake Forest Park from September 1,  
4 1993 - December 31, 1996.
