Attachment A. As Amended by the Regional Policy Committee

King County Local Law and Justice Plan Work Program

Background

The Regional Law, Safety, and Justice Committee (RLSJC) is the designated Local Law and Justice Council for King County. Pursuant to RCW 72.09.300, the RLSJC as the Council for King County is responsible for developing a Local Law and Justice Plan (LLJP). State law also requires that the elements and scope for the LLJP be approved by the county legislative authority. In addition, the motion designating the RLSJC as the Local Law and Justice Council for King County sets a deadline of April 15, 1994 for transmittal of the work program to the Council.

State law requires the plan to address the following areas:

- A. Seek means to maximize local resources including personnel and facilities,
- B. Reduce duplication of services,
- C. Share resources between local and State governments in order to accomplish local efficiencies without diminishing effectiveness, and
- D. Management of the jail population.

Proposal

The LLJP will be a comprehensive assessment of criminal justice services within all jurisdictions in King County. In general, the LLJP will include a description, inventory, and forecast for each component of the criminal justice system. In addition, the system as a whole will be examined for its strengths and weaknesses by developing indicators of the "health" of the criminal justice system. The value of this plan will be indispensable for examining the future requirements for meeting the region's public safety needs and for identifying and implementing efficiencies in the criminal justice system.

The extensive effort to complete the LLJP is probably beyond the resources of any one jurisdiction or group of jurisdictions. However, work must start soon to meet the State requirements. The RLSJC proposes to complete the LLJP in two phases. In 1994, the plan would focus on two components of the criminal justice system: 1) Jail Resources and Population Management and 2) Law Enforcement Services.

<u>Jail Resources and Population Management</u>: Not only does the State require a section on jail related issues but also the severe crowding in King County's facilities necessitates an immediate review of this area.

Law Enforcement Services: All levels of government devote significant portions of their budgets on law enforcement and yet crime remains the major concern of the public. There is a need to define regional and local services and assess any potential gaps in these services. Issues range from inadequate regional records and criminal history systems to defining and implementing community policing. There may be areas of law enforcement where improved coordination could lead to more efficient and effective services. Immediately proceeding with work on law enforcement services will inform both elected officials and the public of potential improvements to law enforcement services and their associated costs.

In 1995, the LLJP will be expanded to include the other components of the criminal justice system such as the courts, prosecution, defense, juvenile detention, and communications.

An outline and schedule for Phase I of the plan is attached.

The RLSJC further proposes that jurisdictions coordinate on a joint staffing effort to develop the plan under the direction of a subcommittee of the RLSJC. The staff workgroup would consist of representatives from King County, City of Seattle, suburban cities, and the State of Washington.
