#### PROJECT SUMMARY

#### SOUTHWEST SEATTLE HISTORICAL SOCIETY (SWSHS)

4022 Beach Drive SW Seattle, WA 98116 Incorporated: 1985

1994 Operating Budget: \$20,289

Organization: Discovers, collects, preserves and exhibits artifacts that establish or illustrate the history of West Seattle, White Center and the Duwamish peninsula; preserves historic buildings and sites; publishes and distributes historical information pertinent to West Seattle, particularly to educational institutions. In last two years, developed a Historic Preservation Plan for the Alki/Harbor Avenue/Duwamish corridor.

<u>Project</u>: Phase I of a three phase project to acquire a historic log house, three blocks from the 1851 landing site of the Denny party. Subsequent phases will restore the house and render it accessible, and establish the Log House Museum as SWSHS's permanent home. Purchase price is \$190,000. City of Seattle is contributing \$170,000; \$5,000 is being raised privately by SWSHS.

Commission approval: based on Cultural Facilities Program 1994 Guide, Page 8, Urgent Need/Emergencies, criteria #4: "An imminent threat of loss or destruction of an historic property or resource." Commission fears that the opportunity to secure and preserve the property for public use will be forever lost.

Total Project Cost (Phase I): \$190,000 Recommended Award: \$15,000
