2 A MOTION CONTINUING THE WORK OF THE
3 VASHON, BOULEVARD PARK/WHITE CENTER AND
4 COVINGTON GOVERNANCE STRATEGIES
5 COMMITTEES AND ESTABLISHING A NEW
6 COMMITTEE FOR EAST SAMMAMISH

7 WHEREAS, the Vashon/Maury Island, Boulevard Park/White
8 Center and Covington Governance Strategies Committees have
9 worked over the last several years to determine how best to
10 address their local governance needs, and

11 WHEREAS, the various committees have evaluated their
12 existing options, and

13 WHEREAS, the Vashon/Maury Island Governance Strategies
14 Committee has expressed strong support for the unincorporated
15 area council, and wishes to employ that option while
16 continuing to consider other possible new options, and

17 WHEREAS, the Covington Governance Strategies Committee
18 has recommended to its community that incorporation be
19 pursued, but is experiencing difficulties with the City of
20 Kent over part of the territory they are interested in, and
21 may need to modify their recommendation, and

22 WHEREAS, the Boulevard Park/White Center Governance
23 Strategies Committee has been awaiting the outcome of the
24 proposed Unincorporated Area Councils ordinance, which is
25 their preferred option in the short term, and which can
26 provide an organized forum from which potential annexations
27 can be addressed, and

28 WHEREAS, the East Sammamish Plateau is a major urban
29 area which is in need of resolving its local governance needs

30 NOW, THEREFORE BE IT MOVED by the Council of King

31 County:

1 Section 1. The Governance Strategies Committee
 2 appointments for Vashon/Maury Island, Covington and Boulevard
 3 Park/White Center are extended through December 31, 1995 for
 4 the purposes of providing a source of information in the
 5 community about governance options and for continuing to
 6 evaluate and pursue alternatives as circumstances
 7 necessitate. Meetings will be held on an as-needed basis.
 8 The council budget for 1995 shall include staff and other
 9 resources to permit effective extension of these Committees.

10 Section 2. A Governance Strategies Committee for the
 11 East Sammamish Plateau Community Planning Area shall be
 12 established in 1995, to consider governance options for the
 13 area. The council budget for 1995 shall include staff and
 14 other resources to support this Committee.

15 Section 3. The membership of these committees shall be
 16 established by the Councilmember or Councilmembers who
 17 represent the area, who shall also be responsible for filling
 18 of vacancies. No further action by motion is required with
 19 regard to membership.
