Administrative costs seem high. The panel questioned the absence of inkind contribution to the project and would have wanted to see other support for the visiting author.

Project: "BRAVO! BALLET, PNB's arts in education program" This project provides students and teachers with the opportunity to learn about and participate in classical ballet. Students attend opera house shows which demonstrate the basics of ballet training and development of sets and costumes. A question and answer session with the dancers will follow. Students may participate in field trips to the Phelps Center and a 45 minute ballet class conducted by a PNB School faculty member. Teachers attend workshops focusing on the fundamentals of ballet companies and history. They receive informational materials for integration into the curriculum. Parents are able to volunteer and attend performances. Funding is requested for the residencies and partial support of the opera house shows.

Panel: The Bravo! Ballet program is an excellent outreach tool. However, this appears to be primarily an enrichment and audience development program. The school partnership is not as strong as it could be. The classroom aspect is underdeveloped. There doesn't seem to be sequential learning for students. The program does not focus on fostering substantive curriculum development in the school. The Committee recommends a follow-up meeting with the Ballet to discuss the specific criteria for the Cultural Education Program.

Project: Through a collaborative effort, children, parents and teachers produce significant works of art to represent their heritage. The resident artist facilitates all projects. At East Hill students and adults develop and create a mural on a wall facing a four lane highway. To beautify the exterior walls of their school, Martin Luther King Jr. students and adults produce several interchangeable works to be displayed. Wing Luke students and adults design a mural on their interior wall.

Panel: Eric Salisbury is an enthusiastic and intuitive artist. Artist work samples were excellent. The project proposal was underdeveloped with no indication of curriculum development. The Kent school project is happening now and is ineligible. There is no clear commitment from the participating schools or any assurance that school staff will dedicate their efforts. The grant application needs to be better developed. The Committee recommends that staff provide technical assistance to this applicant for next year.

Project: "People of Culture: Student Matinee Performances and Cultural Diversity Workshops" This project encourages 400 students to become aware of cultural issues through activities and discussions about The Group's 1995-96 season. The education coordinator and lead teaching artist present teachers with play preview materials so they are able to lead preparatory workshops and interactive writing exercises for students two weeks prior to the performances. The teaching artists conduct a pre-show workshop (one week prior) and a post-play discussion in which students write and discuss their feelings about the play. Through a final workshop instructed by the teaching artist in the classroom, students learn how to re-evaluate their ideas of culture and discuss experiences with peers and staff.

Panel: The school partnership is not as strong as it could be. Not clear what the curriculum of the project is. Not sure how the project fits in with art education. It is more of a study of diversity issues using theater than theater art itself.

Project: "The Festival Education Initiative" This three part project creates an artistic exchange among students, teachers, and artists. Young ESL students and English speaking students in six integrated classrooms participate. Teachers attend workshops with regional artists, Cathy Spagnoli, Annie Penta, and Paramasivam and international artists, Ranganiketan Cultural Arts Troupe. The training culminates at the University of Washington's Festival Mosaic. The regional artists provide 66 hours of in-school residencies and teach students Indian storytelling and folk art. After attending a performance by Ranganiketan at the festival, the students participate in a

workshop with the performers and share their knowledge from the residencies. Parents volunteer at residencies and attend the Ranganiketan performance and workshops.

Panel: The education initiative is a good idea. One of the primary artists in this application, Annie Penta, is funded for a similar curriculum in another school. The Nordic Heritage Museum is funded for a project in this same school. The application did not rank as highly as other projects which addressed the same school, same artist and curriculum. Interesting project but there is insufficient funding to adequately support this project at the present ranking.

Project: "Musical Steps to Learning" Through educational presentations, symphony ensemble residencies in the schools, and a full orchestra concert at the Opera House, the project teaches children classical musical styles and themes. The Symphony's education director conducts six two-hour workshops during the school year to prepare teacher and parent volunteers for music workshops. In consultation with teachers, the volunteers present and incorporate material into the curriculum. Instruction materials are left for continued use. During full-day residencies, musicians meet with groups of students and then perform in ensemble for the entire student body. The students attend a live full orchestra performance at the Opera House.

Panel: The Symphony was funded for its composer workshop last year. This project proposal is not as focused. The partnership link is underdeveloped. It is unclear how the volunteer teachers will be recruited or what their qualifications will be. The Committee questioned why they were not training the teachers themselves for a longer lasting impact to the curriculum. It is not clear how the instruction materials will be used after the project ends. The ensemble residencies are valuable but expensive to fund. Not strong enough to be competitive with other funded applications.

Students evaluate the show in class and theater database. Participating theaters have multicultural staff and artists to lead an answer and question session after the performance.

Panel: Although this is a great idea, it is not within the mission and goals of this program to fund reduced price ticket programs.
