At the April 21 meeting of the Board of Commissioners, Mr. Myron Meikle was in attendance and was interviewed relating to his interest in filling the vacant commissioners position. Mr. Glenn Bressan was unable to attend and Mr., Hamblin had informed us earlier that he would be on vacation and unable to attend. Also in attendance at the April 21 meeting were approximately ten residents of King County Fire District #25. Five of the residents spoke out in opposition to the possible appointment of Mr. Hamblin, stating that he had been seen at public meetings in the past, speaking out against District #25, the current contract for services with the City of Renton Fire Department and had appeared to have a hostile attitude toward fire fighters in general. Enclosed is a copy of the draft of the minutes for the April 21, 1998 meeting for your review. The meeting was tape recorded due to the absence of the district secretary, and some of the comments could not be transcribed due to lack of clarity in the tape recording. All of the citizens in attendance made it clear that they attended the meeting to oppose the appointment of Mr. Hamblin to the board.

Commissioner Don Milbrath and I adjourned to Executive Session at 7:35 PM for approximately 20 minutes to discuss the vacant commissioner position and the district secretary position to be vacated at the end of May. We returned to the regular meeting and informed the residents still in attendance that we were unable to agree on a selection to fill the vacant commissioner position. It is my understanding that in the event that the remaining commissioners cannot agree on a replacement, the decision would be made by the Office of the County Executive. We request your assistance in appointing a qualified resident of Fire District #25 to fill the vacant position as soon as possible.
