### RESOLUTION NO. <u>98-01</u>4

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KENMORE, WASHINGTON, AUTHORIZING A TEMPORARY ANNEXATION OF THE CITY OF KENMORE TO KING COUNTY FIRE PROTECTION DISTRICT NO. 16, UNTIL DECEMBER 31, 1999, AS PROVIDED IN RCW 52.04.161, AND CALLING FOR AN ELECTION TO PERMIT VOTERS TO DETERMINE WHETHER THE CITY SHALL BE ANNEXED TO AND BECOME A PART OF KING COUNTY FIRE PROTECTION DISTRICT NO. 16 PURSUANT TO RCW 52.04.071.

WHEREAS, the City of Kenmore will incorporate on August 31, 1998; and

WHEREAS, portions of the City of Kenmore are located in King County Fire Protection District No. 16; and

WHEREAS, RCW 52.04.161 provides that a newly incorporated city is automatically annexed to a fire protection district within whose borders the City lies unless the City adopts a resolution precluding annexation; and

WHEREAS, RCW 52.04.161 provides that the automatic annexation by the City to the Fire Protection District shall continue through the remainder of the year of the City's official date of incorporation; and

WHEREAS, RCW 52.04.161 provides that the automatic annexation by the City to the Fire Protection District may be extended through the year following incorporation if approved by resolution of the Fire Protection District and the City; and

WHEREAS, RCW 52.04.161 further states that a ballot proposition may be submitted to the voters to decide whether the City shall remain annexed to Fire Protection District No. 16; NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF KENMORE, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

Section 1. Automatic Annexation. The City Council ratifies and extends the automatic temporary annexation of the City to King County Fire Protection District No. 16 pursuant to RCW 52.04.161 commencing on the date of incorporation and terminating on December 31, 1999, unless otherwise further extended.

Section 2. Finding. The City Council finds that it is in the public interest for the City of Kenmore to be annexed to King County Fire Protection District No. 16.

Section 3. Declaration of Intent. It is the intent of the City of Kenmore to be annexed to and be a part of King County Fire Protection District No. 16.

Section 4. Request for Concurrence. Pursuant to RCW 52.04.161 the City requests that the Board of Commissioners of King County Fire Protection District No. 16 concurby resolution in the annexation of the City to the District through December 31, 1999.

Section 5. Transmittal to County Council and Request for Special Election. Pursuant to RCW 52.04.071, if the Board of Commissioners of King County Fire Protection District No. 16 concurs by resolution with the City's intent to be annexed to and become a part of the District, then the City Clerk is authorized and directed to notify and send a certified copy of this Resolution and the District's resolution to the King County Council. The City requests that the County shall by resolution call for a special election to be held in the City and Fire

Protection District No. 16 on September 15, 1998, or at the next date provided in RCW 29.13.010, but not less than forty-five days from the declaration of the finding. The special election shall be held for the purpose of submitting to the qualified voters of the City and the District the proposition of whether the City should be annexed to and become a part of the District. The City further requests that King County shall give notice of the election as provided in RCW 29.27.080. The proposition to be submitted at the special election shall be in the form of a ballot title as follows.

WHEREAS, the City of Kenmore (the "City") will incorporate officially on August 31, 1998, and portions of the newly-incorporated City are located within the geographic boundaries of King County Fire Protection District No. 16 ("District 16"); and

WHEREAS, RCW 52.04.161 provides automatic temporary annexation by the City to District 16, effective immediately on the City's official date of incorporation, that the City shall remain annexed for the remainder of the calendar year, and may remain annexed throughout the following calendar year if the town or city council so provides by resolution; and

WHEREAS, The City of Kenmore has by Resolution chosen to continue the automatic temporary annexation provided for in RCW 52.04.161 until December 31, 1999; and

WHEREAS, RCW 52.04.161 provides that the City will be automatically withdrawn from District 16 on January 1, 2000, unless a ballot proposition is adopted by the voters pursuant to RCW 52.04.071 providing for the permanent annexation of the City to District 16; and

WHEREAS, RCW 52.04.071 provides the method and requirements for an election for the annexation of a city into a fire district; and

WHEREAS, RCW 35.02.130 provides that, at this time, the City may authorize the submittal of a ballot proposition to the voters concerning annexation of the City by District 16; and

WHEREAS, the City has declared its intent to annex into District 16 and has passed a Resolution authorizing the submittal of a ballot proposition to the voters of the City and of District 16 concerning annexation of the City into District 16; and

WHEREAS, the Board of Commissioners of District 16 considers it to be in the best interests of the District and the public to have the City of Kenmore be a part of District 16; NOW THEREFORE,

**BE IT RESOLVED**, that the Board of Commissioners of King County Fire Protection District No. 16 ratifies continuation of the automatic temporary annexation of the City to King County Fire Protection District No. 16 until December 31, 1999 pursuant to RCW 52.04.161; and IT IS FURTHER

**RESOLVED**, that the Board of Commissioners of King County Fire Protection District No. 16 hereby concurs with the City Council of the City of Kenmore in its intent to join District 16 by annexation; and IT IS FURTHER

**RESOLVED**, that copies of this Resolution be sent to the King County Auditor and Treasurer and to the City Council for the newly incorporated City of Kenmore for their records; and IT IS FURTHER

**RESOLVED**, that King County Fire Protection District 16 by this Resolution requests that officials of King County call for a special election to be held, pursuant to RCW 52.04.071, on September 15, 1998, or at the next date provided in RCW 29.13.010, but not less than forty-five days from the date of passage of this Resolution, for the purpose of submitting to the voters of the City and the District a ballot proposition in substantially the following form:
