A MOTION relating to the meeting schedule for the committees of the council.

WHEREAS, in the interests of the citizens of King County and the efficiency of the operations of the county, the council appoints its duties and responsibilities among several standing council, and

WHEREAS, Section 270 of the King County Charter establishes the duties and responsibilities of three regional committees of the council, and

WHEREAS, the Washington State Open Public Meeting Act, chapter 42.30RCW, requires the council to establish regular meeting times, and

WHEREAS, the council's rules establish the time of the regular meetings of the council, but do not establish the times for meetings of the standing and regional committees, and

WHEREAS, a legislative motion adopted by a majority of the council members establishing the regular meeting times of the standing and regional committees would formally notify the public and meet the requirements of chapter 42.30 RCW;


