1 A MOTION relating to council committees, establishing the
2 membership and regular meeting times for the committees of
3 the council, and rescinding Motions 10625 and 10831.

4 WHEREAS, in the interests of the citizens of King County and the efficiency of
5 the operations of the county, the council appoints its duties and responsibilities among
6 several council committees established in Motion 10836, and

7 WHEREAS, current committee membership was established by Motion 10831,
8 and

9 WHEREAS, the council's rules provide that changes to current committee
10 membership be made only by formal legislative motion adopted by a majority of the
11 council members at a council meeting, and

12 WHEREAS, Section 270 of the King County Charter establishes the duties and
13 responsibilities of three regional committees of the council, and

14 WHEREAS, K.C.C 1.24.035 establishes the time of the regular meetings of the
15 council, but does not establish the times for regular meetings of the standing and regional
16 committees, and

17 WHEREAS, Motion 10625 previously established the regular meeting times of

18 the standing and regional committees to formally notify the public and meet the
19 requirements of chapter 42.30 RCW, and

20 WHEREAS, in order to coordinate the meeting schedules of committees and their
21 members it is necessary to modify some of the previously-adopted regular meeting times
22 from those set forth in Motion 10625,

23 NOW, THEREFORE BE IT MOVED by the Council of King County:

24 A. Motions 10625 and 10831 are hereby rescinded.

25 B. In addition to the committee chairs and vice-chairs appointed by Motion
26 10836, the chair hereby appoints and the council confirms the following councilmembers
27 to the committees created in Motion 10836.

28 C. The council hereby confirms the following schedule for the regular meetings
29 of the standing committees created in Motion 10836 and the regional committees
30 established in the King County Charter.




