                  WHEREAS, in the 1998 budget the council directed that the council auditor  
8 contract for monitoring and review of and comment on the implementation of the  
9 financial systems replacement program, and

                  WHEREAS, Pacific Consulting Group, Inc. entered into a contract to provide  
11 those services under contract number T00558T, and

                  WHEREAS, two projects of the financial systems replacement program, the  
13 payroll/HR system project and the core financials project, have been suspended, and

                  WHEREAS, the county is to conduct payroll stabilization and replanning efforts  
15 by December 31, 2000, and the council desires these efforts to be monitored by the  
16 independent consultant hired by the county auditor, and

17           WHEREAS, the Pacific Consulting Group is in a unique position to continue its  
18 prior work monitoring the payroll stabilization, documentation and replanning processes,  
19 and the council finds that it would be beneficial to amend the existing contract to expand  
20 the scope of services of the contract and increase the compensation provision to  
21 compensate the Pacific Consulting Group for this added work, and

22           WHEREAS, the cost of employing the consultant shall be paid from CIP project  
23 number 344101, financial systems replacement program,

24           NOW, THEREFORE, BE IT MOVED by the Council of King County:

25           The current contract for \$332,785 is ratified and the chair of the metropolitan  
26 King County council is authorized to amend the current contract with the Pacific  
27 Consulting Group to continue its monitoring of the payroll stabilization, documentation,

28 and replanning processes related to the financial systems replacement program for a total  
29 amount not to exceed \$464,285.


