2 regular meeting times for the committees of the council, and rescinding Motion 10840.

6 WHEREAS, in the interests of the citizens of King County and the efficiency of
7 the operations of the county, the council appoints its duties and responsibilities among
8 several council committees established in Motion 10836, and

9 WHEREAS, current committee membership was established by Motion 10840,
10 and

11 WHEREAS, the council's rules provide that changes to current committee
12 membership be made only by formal legislative motion adopted by a majority of the
13 council members at a council meeting, and

14 WHEREAS, Section 270 of the King County Charter establishes the duties and
15 responsibilities of three regional committees of the council, and

16 WHEREAS, K.C.C 1.24.035 establishes the time of the regular meetings of the
17 council, but does not establish the times for regular meetings of the standing and regional
18 committees, and

19 WHEREAS, Motion 10840 previously established the regular meeting times of
20 the standing and regional committees to formally notify the public and meet the
21 requirements of chapter 42.30 RCW, and

22 WHEREAS, in order to coordinate the meeting schedules of committees and their
23 members it is necessary to modify some of the previously-adopted regular meeting times
24 from those set forth in Motion 10840,

25 NOW, THEREFORE BE IT MOVED by the Council of King County:

26 A. Motion 10840 is hereby rescinded.

27 B. In addition to the committee chairs and vice-chairs appointed by Motion
28 10836, the chair hereby appoints and the council confirms the following councilmembers
29 to the committees created in Motion 10836.

30 C. The council hereby confirms the following schedule for the regular meetings
31 of the standing committees created in Motion 10836 and the regional committees
32 established in the King County Charter.


