1 A MOTION authorizing the chair of the council to enter into a
2 contract amendment with Daystar, Inc. for further customization
3 of the legislative management system approved in Motion
4 10525, and amended in Motion 10589, which will provide
5 additional public and employee access to the system.

WHEREAS, in Motion 10525 the council authorized the chair of the metropolitan King
8 County council to enter into a contract in an amount not to exceed \$175,670. with Daystar
9 Computer Systems, Inc. for the design, installation, training and maintenance of an automated
10 legislative management system, and

WHEREAS, in Motion 10589 the council authorized the chair of the metropolitan King
County council to execute an amendment to the contract with Daystar Compute Systems, Inc. in
13 an amount not to exceed \$20,000 for further customizations to the council's automated
14 legislative management system, and

WHEREAS, the ability of the technology associated with this automated legislative
management system has advanced to allow for WEB based public access of the information
contained in the legislative management system, and

WHEREAS, council staff continually receive requests for internet access to legislative
records from the public and from County agencies, and

20 WHEREAS, WEB access will increase the information directly available to the public
21 and to county employees. This enhancement will provide this information in a more cost and
22 labor efficient way and reduce the need for additional legislative management system software
23 licenses, and

24 WHEREAS, the additional costs to provide the WEB based modules is approximately
25 \$32,000 in 2001 with an annual \$4,000 maintenance fee. Funding for this amendment is
26 available from current technical project funds and within current budget appropriation,

27 NOW, THEREFORE BE IT MOVED by the Council of King County:

28 The chair of the metropolitan King County Council is authorized to execute an
29 amendment to the contract with Daystar Computer Systems, Inc., for WEB based customization
30 to the council's automated legislative management system. The amount of the contract

31 amendment shall not exceed \$36,000, excluding amounts in further years for maintenance fees.




