WHEREAS, K.C.C. 3.16.015 authorizes the council to designate in its
organizational motion a committee responsible for establishing labor policy;

18	NOW, THEREFORE, BE IT MOVED by the Council of King County:
19	I. Motion 11122, Section B, as amended, and OR 2-010 are each hereby
20	amended to read as follows:
21	Committee-of-the-whole – functions. The council may go into committee-of-
22	the-whole at any time. The committee-of-the-whole shall consider: issues of interest to
23	the entire council, including the annual work program and appointments to the state
24	legislature and to the executive branch; the annual legislative program; agendas for
25	council meetings; and other program and policy matters. For the purposes of K.C.C.
26	chapter 3.16, the committee-of-the-whole is designated as the committee responsible for
27	establishing labor policy. The committee-of-the-whole shall consider labor policy
28	issues at least quarterly.
29	II. Motion 11122, Section D, as amended, and OR 2-020 are each hereby
30	amended to read as follows:
31	Committees – functions. In addition to any committee otherwise established
32	by law, the committees of the metropolitan King County council and their respective
33	functions are established as follows:
34	A. Budget and fiscal management committee shall: review and monitor the
35	budget, including financial plans, revenues, expenditures, quarterly reports, and capital
36	improvement programs; monitor the financial status of county funds; consider and make
37	recommendations to all supplemental appropriations; and consider and make
38	recommendations on debt and investment proposals, levies, fees and taxes. In respect to
39	consideration of the county's annual budget, all members of the council not assigned to
40	the budget and fiscal management committee will be considered ex officio voting

41 members of the committee.

42 B. Growth management and unincorporated areas committee shall consider 43 and make recommendations on policies relating to land use development, comprehensive planning, development regulations, regulatory reform and recommendations to the 44 45 department of development and environmental services (DDES). In respect to 46 consideration of updates of the Comprehensive Plan, all members of the council not 47 assigned to the growth management and unincorporated areas committee will be 48 considered ex officio voting members of the committee. The chair of the committee may 49 refer various portions of the Comprehensive Plan to panels of members. The chair of the committee may employ the various standing committees as panels. The panels shall 50 51 transmit their recommendations to all councilmembers for their consideration as regular 52 or ex officio members of the growth management and unincorporated areas committee 53 before the committee refers the annual update of the Comprehensive Plan to the full council. 54 55 The committee shall consider and make recommendations relating to: market rate 56 housing and housing affordability; Growth Management Planning Council (GMPC), 57 including GMPC task forces, timelines, products (such as benchmarking and land 58 capacity), and Countywide Planning Policies; Potential Annexation Areas and interlocal 59 agreements; boundary review board and nonutility annexations; planned action environmental impact statements and related phased state Environmental Policy Act 60 61 review; and the Puget Sound Regional Council; and development and land use

62 regulations necessary to either implement salmon recovery or comply with the

63 Endangered Species Act, or both.

64	The committee shall: consider and make recommendations on King County	
65	motions and ordinances which have force and effect only in the unincorporated areas of	
66	the county; evaluate and make recommendations on the quality of service delivery in	
67	areas such as police, roads and human services; and consider and make recommendations	
68	relating to subarea planning community councils and other unincorporated self-	
69	government strategies.	
70	C. Labor, operations and technology ((and government operations))	
71	committee shall:	
72	1. Consider and make recommendations on policies relating to management	
73	organizational structure; customer service; the efficiency, cost effectiveness and	
74	performance of county departments, including: assessor; personnel; purchasing; civil	
75	rights and compliance; real property management; general services; records and	
76	elections; facilities management; risk management; safety and worker's compensation;	
77	and cooperative extension community services;	
78	2. Consider and make recommendations to the full council on the annual audit	
79	program;	
80	3. Consider and make recommendations to the full council on labor agreements;	
81	4. ((Review complaints filed pursuant to K.C.C. 3.16 by bargaining	
82	representatives)) For the purposes of K.C.C. chapter 3.16, is designated as the labor	
83	implementation committee;	
84	5. Consider and make recommendations relating to municipal service contracts;	
85	6. Consider DDES efficiency and customer service; and	
86	7. Consider and make recommendations relating to information technology,	

87	cable communications and telecommunications issues.
88	D. Law, justice and human services committee shall:
89	1. Consider and make recommendations on policies relating to: public safety;
90	adult detention; constitutional and human rights; discrimination; civil and criminal
91	liability; ethics; campaign practices; juvenile justice programs; youth services; the
92	superior and district courts; judicial administration; prosecuting attorney; and public
93	defense; and
94	2. Consider and make recommendations on matters relating to personal and
95	environmental health; mental health; developmental disabilities; alcoholism and
96	substance abuse; emergency medical services; human services; families and children;
97	women's programs; and aging programs.
98	E. Legislative steering committee shall consider and make recommendations to
99	the full council on legislation before the federal, state and local governments that affect
100	King County. The committee shall meet regularly with all branches of King County
101	government to review legislation and policies that affect them and to coordinate the
102	county response to issues from other levels of government.
103	F. Natural resources, parks and open space committee shall consider and
104	make recommendations on natural resources policies relating to: cultural resources;
105	recreation programs; issues relating to the Endangered Species Act; parks; open space;
106	agricultural lands; and resource lands.
107	G. Transportation committee shall consider and make recommendations on
108	policies relating to: transportation; planning; roads; engineering; and public
109	transportation.

110	H. Utilities committee shall make recommendations relating to: utility services
111	(including wastewater treatment, solid waste management, flood control, and
112	surfacewater and stormwater management); utility annexations; utility comprehensive
113	plans and franchises; and water quality and water quantity issues.
114	III. Motion 10651, Section V, as amended, and OR 2-030 are each hereby
115	amended to read as follows:
116	OR 2-030. Employment committee.
117	A. Membership requirements – duties. The employment committee shall
118	consist of four members and two alternates. Two members and one alternate shall be
119	from the majority party and two members and one alternate shall be from the minority
120	party. The only time an alternate may vote is when a regular member of the same party is
121	absent. If a regular member of the employment committee cannot attend an employment
122	committee meeting, an alternate member may be appointed. The chair of the council
123	shall appoint the alternate for an absent member from the majority party. The minority
124	caucus shall appoint the alternate for an absent member from the minority party. An
125	appointment of an alternate must be in writing and filed with the clerk of the council and
126	the chair of the employment committee. Alternate employment committee members may
127	be designated for either a specific meeting or for any meeting at which an absence might
128	occur in the future. A quorum of the employment committee shall consist of three
129	committee members.
130	The vice-chair of the council shall chair the committee.
131	B. Process.
132	1. Personnel decisions. The employment committee shall make

133	recommendations to the full council concerning decisions for legislative branch
134	employees, except for councilmembers' personal staff. Personnel decisions include
135	decisions to hire, to fill vacancies, to make staffing adjustments, to assign or reassign
136	staff, to adjust staff pay, to analyze future hiring needs and to make other necessary
137	employment decisions. Personnel decisions do not include termination or disciplinary
138	decisions, which follow the process stated in subsection B.2 of this section. Employment
139	committee recommendations on personnel decisions shall be contained in a written
140	recommendation report that shall, upon signature of ((two)) three committee members, be
141	sent to the full council. The council shall consider the recommendation reports from the
142	committee on an employment committee consent agenda. ((However, in the event the
143	employment committee forwards two recommendations to the council on the same
144	matter, the two recommendations shall be considered separately from the consent
145	agenda.))
146	2. Terminations and disciplinary decisions. The employment committee
147	makes decisions on discipline and termination, including layoffs. If three
148	committee members vote for a termination or disciplinary action the decision is
149	final, except when an employee exercises the right of an appeal to the full council.
150	An employee who has been either suspended without pay of two weeks or more,

An employee who has been either suspended without pay of two weeks or more, or terminated may appeal the decision of the employment committee to the full council. The appeal must be filed with ten calendar days of written notice of the suspension or termination being sent to the employee. An appeal is accomplished by delivering a notice of appeal to the clerk of the council. Nondisciplinary terminations are subject to appeal in the same manner as disciplinary

156	terminations. ((If only two members vote to recommend a termination or
157	disciplinary action, the recommendation should be forwarded to the full council
158	for consideration in the manner set forth in subsection B.1 of this section.))
159	3. Nothing in this process is to be construed to alter the at-will status of
160	legislative branch employees. This process is designed to facilitate the will of the
161	majority of the council.
162	C. Removal of recommendations from consent agenda. Upon the request of
163	any member present before the full council, any specific recommendation from the
164	employment committee shall be removed from the consent agenda and considered
165	separately by the council prior to adoption of the employment consent agenda. The
166	council may then by a majority vote make whatever orderly disposition of the matter it
167	deems appropriate.
168	D. Motions for censure. The employment committee shall consider and make
169	recommendations on motions for censure related to alleged violations of any
170	antiharassment policy by a councilmember.
171	E. Personnel records as confidential. To the extent permitted by law, personnel
172	records which would be exempt from public disclosure shall continue to be treated as
173	confidential and records or portions thereof which are exempt shall be conspicuously
174	identified as such and separated from nonexempt records.
175	IV. Motion 11122, Section G, as amended, and OR 2-040 are each hereby
176	amended to read as follows:
