1 A MOTION declaring the council's support for legislation 2 that would modify existing state law to allow King County the authority to refer a local option sales tax of one-tenth of 3 4 one percent to a vote of the people to fund health and 5 human services that have historically been funded and 6 provided at the local level. 7 8 9 WHEREAS, King County is working to manage a current expense (CX) general 10 fund deficit of approximately \$140 million over four years, including a deficit of 11 approximately \$50 million in 2004-2005, and 12 WHEREAS, although King County continues to increase internal efficiency and 13 reorganize its functions in order to reduce its spending significantly, the county can no 14 longer afford to deliver many services to its residents, and 15 WHEREAS, King County is dependent on a strong fiscal partnership with the 16 state, despite projected state revenue declines. If King County is going to be able to

17	continue delivering basic government services to our residents, King County needs a
18	preservation – if not an expansion – of state support, and
19	WHEREAS, if the state is not able to expand support to adequately fund the
20	mandates upon local government, revenue tools should be provided to local governments
21	to allow funding for services historically provided by local governments, and
22	WHEREAS, King County has historically funded and provided a variety of local
23	health and human services throughout the county, including services in both incorporated
24	and unincorporated areas, and
25	WHEREAS, King County government is without the revenue tools to support
26	health and human services that have historically been provided at the local level in King
27	County.
28	NOW, THEREFORE, BE IT MOVED by the Council of King County:
29	The council supports legislation that would modify existing state law to allow
30	King County the authority to refer a local option sales tax of one-tenth of one percent to a

31 vote of the people to fund health and human services that have historically been provided

32 at the local level or transit. Priorities for regional funding would be presented to voters

33 after public hearings and consultation with city officials.
