A MOTION approving transit security policies. 2 3 4 WHEREAS, the safety of its customers and employees is King County metro 5 transit's highest priority, and 6 WHEREAS, King County has demonstrated its commitment to providing safe and 7 attractive transit service by establishing the Transit Code of Conduct as a means of 8 defining and enforcing civil behavior on its vehicles and properties, and 9 WHEREAS, King County has steadily increased its investment in transit security 10 by contracting with the King County sheriff to create a full-time dedicated transit police 11 force to augment its long term use of off-duty Seattle police officers, and 12 WHEREAS, King County recognizes that, in order to succeed, transit security 13 must be a joint endeavor undertaken in partnership with local law enforcement agencies 14 throughout the transit service area, and 15 WHEREAS, all parties involved in providing transit security would benefit from 16 the establishment of transit security polices to formalize existing strategies and provide 17 additional guidance, and

A. Transit Security Policies

Transit Security Policies

- The Transit Division should provide clear and consistent direction on the operator's role in fare collection and enforcement of the Transit Code of Conduct.
- 2. The Transit Division should emphasize public awareness of the Transit Code of Conduct and ensure that there are consistent and predictable consequences for violations.
- 3. The Transit Division should work with its operators to improve the quality of reporting of fare evasion and security incidents.
- 4. The Transit Police should establish partnerships with local law enforcement agencies to ensure prompt incident response and full sharing of transit-related crime data.
- 5. King County should increase the proportion of full-time officers on its Transit Police by shifting some of the resources currently expended on part-time policing by off-duty municipal officers. This should be done incrementally to determine the appropriate balance between the added productivity and flexibility of full-time dedicated officers and the benefits of using off-duty municipal officers.
