1	A MOTION relating to growth management, supporting
2	efforts by the city of North Bend to comply with the state
3	Growth Management Act, the Countywide Planning
4	Policies and the King County Comprehensive Plan by
5	accommodating growth within the city's adopted Urban
6	Growth Area and providing that growth with appropriate
7	water service.

10	WHEREAS, in anticipation of the need for additional water sources to
11	accommodate future growth, the city of North Bend submitted a water rights application
12	(G1-26617) in 1992, based on the service boundaries of the Coordinated Water System
13	Plan, that was then in effect, and
14	WHEREAS, subsequent to the submittal of the water rights application, the state
15	passed the Growth Management Act in 1994, and
16	WHEREAS, one of the guiding tenets of the state Growth Management Act is to
17	foster growth within the newly identified Urban Growth Areas delineated by local

18	counties and cities in their respective county planning policies and comprehensive plans.
19	and
20	WHEREAS, that growth is to occur in an orderly manner, wherein jurisdictions
21	work cooperatively to efficiently provide urban services, such as public water systems,
22	and
23	WHEREAS, public water systems should where possible share resources and
24	coordinate planning efforts to reduce redundant infrastructure improvements and avoid
25	gaps in urban-level services, and
26	WHEREAS, the general goal of several key policies of the Countywide Planning
27	Policies and King County Comprehensive Plan, shown on Attachment A to this motion,
28	is to:
29	1. Ensure that cities are the primary service providers for development within the
30	Urban Growth Areas;
31	2. Prevent the proliferation of small public (Group B) water systems and private
32	exempt wells within the Urban Growth Area, due to reliance on shallower aquifers and
33	impacts to groundwater providing flows to streams, often used by salmonids; and
34	3. Promote efficient use and sharing of resources between service providers
35	within the Urban Growth Area, and
36	WHEREAS, the Countywide Planning Policies, the King County Comprehensive
37	Plan and the city of North Bend comprehensive plan are consistent in their delineation of
38	the Urban Growth Area for the city of North Bend, that includes a significant area to the
20	and of the augment city houndaries and

40	WHEREAS, lacking the additional water resources that would be available
41	through the approval of the water rights application, the City of North Bend enacted an
42	ordinance in 1999 establishing a moratorium on all new building and development, and
43	WHEREAS, the city moratorium has resulted in the shifting of growth pressures
44	to the portion of the North Bend Urban Growth Area located outside of the current city
45	boundary, in which water service is provided by the Sallal Water Association, and
46	WHEREAS, the Sallal Water Association anticipates that their current available
47	water resources can accommodate only several more years of additional development
48	before having to deny service to new customers, and
49	WHEREAS, denial of service by the Sallal Water Association will cause a
50	proliferation of smaller Class B water systems or exempt private wells within the North
51	Bend Urban Growth Area served by the Sallal Water Association, and
52	WHEREAS, this proliferation of smaller Class B water systems or exempt private
53	wells within the Urban Growth Area is not consistent with the Countywide Planning
54	Policies and the King County Comprehensive Plan, and may impact stream flows without
55	mitigation, and
56	WHEREAS, an application for a water right by the Sallal Water Association, in
57	order to avoid the proliferation of smaller water system and private wells and meet the
58	demands for growth within the Urban Growth Area would not be approved for many
59	years due to the limited resources of the state to process water rights applications, and
60	WHEREAS, the state legislature recently passed House Bill 1338, which would
61	allow future updates or amendments to the North Bend Water System Plan to identify a
62	larger service area within the North Bend Urban Growth Area, effectively changing the

WHEREAS, the designation the entire North Bend Urban Growth Area as the place of use of North Bend's water right application would facilitate the ability of the Sallal Water Association to provide water to that portion of the North Bend Urban Growth Area which they currently serve, without resorting to a new water rights application, and would allow for an efficient sharing of water resources between service providers, consistent with the Countywide Planning Policies and the King County Comprehensive Plan, and

WHEREAS, limiting the place of use of the North Bend application to its current water service area boundary would not recognize the boundaries of the Urban Growth Area for the city of North Bend and would be inconsistent with a basic tenet of the state Growth Management Act, was well as the Countywide Planning Policies, King County Comprehensive Plan and North Bend comprehensive plan, and

WHEREAS, King County has a responsibility to ensure that all land use related decisions made at the local, as well as, state level are consistent with the law and is obligated to act when there is a potential for actions inconsistent with the law;

NOW, THEREFORE, BE IT MOVED by the Council of King County:

A. The council supports the city of North Bend in its goal of accommodating growth within the adopted Urban Growth Area delineated in the Countywide Planning Policies, King County Comprehensive Plan and city of North Bend comprehensive plan; and

B. The council calls upon the state Department of Ecology to expedite approval
of the city's current water rights application, and
C. The council calls upon the state Department of Ecology to designate the city
of North Bend Urban Growth Area as the place of use for water right application G1-
26617 and to grant approval of the application to permit water service for all areas within
the current North Bend Urban Growth Area.

COUNTYWIDE PLANNING POLICIES

Urban Development

Urban development standards do not include private wells and the smaller Group B water systems are discouraged.

- LU- 26 The lands within Urban Growth Areas shall be characterized by urban development....
- FW- 13 Cities are the appropriate provider of local urban services to Urban Areas either directly or by contract. Counties are the appropriate provider of most Countywide services. Urban services shall not be extended through the use of special purpose districts without the approval of the city in whose potential annexation area the extension is proposed. Within the Urban Area, as time and conditions warrant, cities should assume local urban services provided by special purpose districts.

KING COUNTY COMPREHENSIVE PLAN POLICIES

Coordination of Services

King County is not a water utility and does not provide potable water to citizens in the region. However, it plays an important role in the coordination or linking of water supply and growth.

F- 102 King County shall work with cities, special purpose districts, other local service providers and citizens to identify and distinguish local and countywide services. Over time, cities will assume primary responsibility for coordinating the provision of local services delivery. The County will assume primary responsibility for coordinating the provision of countywide services, including countywide services that must be delivered within city boundaries. The County will also work with cities, special purpose districts, and other counties to identify regional service and facility needs and develop strategies to provide them.

Potable Water Systems

Potable water is provided by Group A public water systems having 15 or more connections, Group B public water systems having 2 to 14 connections, and private wells serving one connection. The type of water system required will depend upon whether a proposed development is or is not located within the Urban Growth Area.

F- 225 In the Urban Growth Area all new construction and all new subdivisions shall be served by Group A public water systems except in the circumstance when no Group A public water system can provide service in a timely and reasonable manner per RCW 70.116.060...

Utility System Interties

Water utilities obtain water supplies from many varying sources. Some water utilities receive the vast majority of their water supply from wells. Yet others receive substantial portions from municipal watersheds and reservoirs. The varying water supply sources can differ substantially in terms of dependability of output, so that while one water utility may have excess capacity, a neighboring water utility could be experiencing severe shortages and be unable to adequately serve their customers.

F- 231 King County supports interties that allow the transfer of water resources among water utilities in urban areas to meet the projected demands for growth. The transfer of water must be consistent with locally adopted growth management plans and approved Coordinated Water System Plans and implement approved Endangered Species Act response requirements and Clean Water Act requirements.
