16 NOW, THEREFORE, BE IT MOVED by the Council of King County:





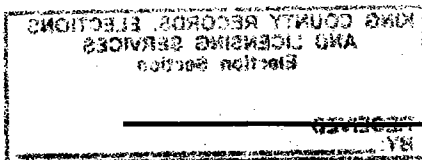
