106 The first and third Tuesdays of each month at 9:30 a.m., unless the
107 committee of the whole is meeting at that time because the preceding

108 Monday was a state or county holiday. ((Also, the second and fourth
109 Tuesdays of each month at 1:30 p.m., unless the council is meeting at that
110 time because the preceding Monday was a state or county holiday.))

111 Labor, operations and technology committee:

112 The second and fourth Tuesday of each month at 9:30 a.m., unless the
113 committee of the whole is meeting at that time because the preceding
114 Monday was a state or county holiday.

115 Law, justice and human services committee:

116 First and third Thursdays of each month at 9:30 a.m.

117 Natural resources and utilities committee:

118 First, second and third Thursday of each month at 1:30 p.m.

119 Transportation committee:

120 The second and fourth Wednesday of each month at 1:30 p.m.

121 Regional policy committee:

122 The first Wednesday of each month at 3:00 p.m.

123 Regional transit committee:

124 The third Wednesday of each month at 3:00 p.m.

125 Regional water quality committee:

126 The second Wednesday of each month at 3:00 p.m.

127 IV. In recognition of the fact that committee agendas may have previously been
128 issued for meetings occurring during the week this motion is adopted, any committee for


