**Proposed No.** 2007-0340.1 **Sponsors** Constantine 1 A MOTION authorizing the King County executive to 2 accept a donation of five hundred thousand dollars from the Starbucks Coffee Company for the support of King County 3 parks and White Center Heights park volunteer 5 improvements. 6 7 WHEREAS, King County prides itself on finding partners who will work with us 8 to increase community and park amenities to ensure parks serve to enhance communities 9 and our regional quality of life, even during tight fiscal times, and 10 WHEREAS, gifts that preserve open space, provide new amenities and support 11 specific facilities are tangible ways of making a difference now and for future 12 generations, and 13 WHEREAS, under the omnibus parks Ordinance, Ordinance 14509, the King 14 County parks and recreation division has the authority to solicit gifts from individual, 15 foundation and corporate sources, and

16	WHEREAS, under K.C.C. chapter 2.80, any and all gifts for parks and recreation
17	purposes that exceed fifty thousand dollars require acceptance on behalf of King County
18	by the King County council by motion, and
19	WHEREAS, all gifts to the King County parks and recreation division are used
20	only for parks purposes, and
21	WHEREAS, the Starbucks Coffee Company is pleased to have the opportunity to
22	show its support for King County parks as the recipient of a Starbucks Parks Fund
23	signature gift, and
24	WHEREAS, this generous gift will support King County parks, White Center
25	Heights park and volunteer improvements of White Center Heights park, and
26	WHEREAS, the parks and recreation division business plan emphasizes
27	generation of entrepreneurial revenues, including pursuing gifts, bequests and donations,
28	which are budgeted in the parks and recreation division operating fund as operating
29	revenues, and
30	WHEREAS, gifts in support of parks and recreation facilities and programs are to
31	be credited to the parks trust and contribution fund before being transferred to the parks
32	operating fund to support King County parks and the volunteer project, and
33	WHEREAS, the King County parks and recreation division is working with the
34	White Center community to host a "Starbucks Ultimate Park Makeover" at White Center
35	Heights park, a volunteer project in June 2007 with the mission of transforming a park
36	into an important neighborhood asset with a variety of enhanced public spaces and
37	amenities, and

38	WHEREAS, the Starbucks Ultimate Park Makeover volunteer improvements will
39	leverage a Starbucks gift with volunteer and other in-kind support for maximum impact,
40	and
41	WHEREAS, the Starbucks Coffee Company wishes to make a donation of five
42	hundred thousand dollars to support King County parks and the volunteer project
43	improvements to White Center Heights park;
44	NOW, THEREFORE, BE IT MOVED by the Council of King County:
45	The King County department of natural resources and parks is authorized to
46	accept a donation of five hundred thousand dollars from the Starbucks Coffee Company
47	for the support of King County parks and White Center Heights park volunteer project
