1 A MOTION authorizing the chair of the council to enter
2 into a contract with Granicus for the installation and
3 maintenance of a streaming video management system and
4 a contract amendment with Daystar Computer Systems,
5 Inc., for further customization of the legislative
6 management system approved in Motion 10525.

8 WHEREAS, there are approximately eight hundred pieces of legislation each year
9 introduced by members of the metropolitan King County council, and

10 WHEREAS, the council in 2000 purchased a legislative management system from
11 Daystar Computer Systems, Inc. ("Daystar"), which has provided enhanced management
12 and tracking services to the public, the council, and county staff through the Internet, and

13 WHEREAS, Daystar has served the county well, providing online public access
14 to the council's business through legistar and legisearch, and

15 WHEREAS, upon review of the council's current requirements it appears that
16 further customization of the automated legislative management system is necessary to
17 meet the needs of the public, the council and county agencies, and

18 WHEREAS, a contract amendment for three thousand dollars, which includes
19 installation and maintenance has been negotiated with Daystar, and

20 WHEREAS, King County Television has been providing a valuable public
21 service through delivery of online streaming video of the council's meetings since 2001,
22 and

23 WHEREAS, citizens have asked for enhanced streaming video services, including
24 indexing of meetings and other events, and integration of the streaming video with the
25 council's legislative management system, and

26 WHEREAS, Granicus is a partner with Daystar in providing such streaming video
27 services, and

28 WHEREAS, council staff has exercised due diligence in identifying Granicus as
29 the most suitable vendor to provide the streaming video services that will integrate with
30 the Daystar legislative management system;

31 NOW, THEREFORE, BE IT MOVED by the Council of King County:

32 A. The chair of the metropolitan King County council is authorized to execute an
33 amendment to the contract with Daystar Computer Systems, Inc., in an amount not to
34 exceed three thousand dollars for further customizations to the council's automated
35 legislative management system; and

36 B. The chair of the metropolitan King County council is authorized to enter into a
37 contract, substantially in the form attached to this motion, in the amount not to exceed

38 ninety-one thousand dollars with Granicus for the design, installation, training and
39 maintenance of a streaming video management system.
