Constantine, Dunn, Phillips and Patterson 1 A MOTION directing the executive to convene a task force 2 to undertake the review of measures intended to encourage 3 the continued viability of agriculture within the Snoqualmie 4 Valley Agricultural Production District. 5 6 WHEREAS, the Growth Management Act ("GMA"), Countywide Planning 7 Policies ("CPPs") and King County Comprehensive Plan ("KCCP") require the 8 delineation and protection of valuable and increasingly limited agricultural resource lands 9 and supports regulations that serve to encourage the continuation of agriculture land uses. 10 and 11 WHEREAS, King County has identified and designated a number of Agricultural 12 Production Districts (APDs) totaling forty-two thousand acres and has implemented 13 protections through the Agriculture zoning designation, and 14 WHEREAS, King County has enacted land use policies and regulations that focus 15 much of the agriculture within the county towards the APDs and financially supports 16 agriculture through:

17	1. Agricultural programs, such as the Farmland Preservation Program, Puget
18	Sound Fresh and farm ditch maintenance; and
19	2. Funding of the King Conservation District for development of farm
20	management plans, and
21	WHEREAS, the Snoqualmie Valley APD is the single, largest APD in King
22	County and historically has had a very productive agricultural industry, and
23	WHEREAS, the Snoqualmie Valley APD is regularly inundated by flood waters
24	due to high levels of precipitation and in the past sixteen years has experienced four of
25	the highest floods on record, with the likelihood of more frequent occurrences in the
26	future, and
27	WHEREAS, these flood water levels are often increased by a number and variety
28	of factors, such as:
29	1. Storm water from development on the uplands that drain into the Snoqualmie
30	Valley; and
31	2. The construction of flood control levees along the downstream portions of the
32	Snoqualmie river that result in the backup of flood waters, and
33	WHEREAS, the regular occurrence of flooding has greatly impacted agriculture
34	within the Snoqualmie Valley APD due to:
35	1. The damage to crops;
36	2. An inability to plant due to water-logged soils;
37	3. A lack of elevated farm pads that provide safe havens for farm animals and on
38	which structures could be placed to protect to farm products, such as seeds, flower bulbs,

39	hay and similar products, and equipment and allow the continuation of farm activities
40	such as milking of dairy cows; and
41	4. The inability to rebuild flood-damaged buildings if the damage exceeds fifty
42	percent of assessed value, and
43	WHEREAS, the federal Food and Drug Administration considers flood inundated
44	food items, including produce in the ground, to be contaminated (also known as
45	"adulterated") and must be destroyed, and
46	WHEREAS, the flood occurrences of November and December 2006 have served
47	as a warning that unless King County evaluates, develops and implements significant
48	protection measures, the continued viability of agriculture in the Snoqualmie Valley APD
49	will be irretrievably compromised, and
50	WHEREAS, it is consistent with the GMA, CPPs and KCCP for the county to
51	support not only the continuation, but also the future growth, of agriculture in the
52	Snoqualmie Valley APD;
53	NOW, THEREFORE, BE IT MOVED by the Council of King County:
54	A. The King County executive is directed to convene a task force to review and
55	make recommendations in regards to farm protection measures for the Snoqualmie
56	Valley APD, such as, but not limited to, the:
57	1. Expansion of opportunities to construct "farm pads" to save livestock,
58	equipment, and products such as, seeds, bulbs and hay or other feed;
59	2. Ability to repair flood-damaged building regardless of the assessed value;

60	3. Application of expanded storm drainage technology and requirements,
61	including berms, for urban developments which contribute storm water into the
62	Snoqualmie river basin; and
63	4. Implementation of a flood control program within the Snoqualmie Valley
64	APD that focuses upon the reduction of flooding to farmlands.
65	B. The task force shall be comprised of:
66	1. Representatives from departments or divisions such as but not limited to
67	Department of Development and Environmental Services and Water and Land Resources
68	Division as appointed by the King County executive;
69	2. A representative appointed by the King Conservation District Board;
70	3. A farmer appointed by the King County Agriculture Commission; and
71	4. A representative of the Hmong farming community.
72	C. The executive is directed to complete the task force review and forward
73	recommendations to the King County council by February 1, 2008, in order to allow
74	implementation of agriculture protection standards prior to the start of the 2008/2009
75	flood season. Eleven copies of the recommendations shall be filed with the clerk of the

council, who shall forward a copy to each councilmember and the lead staff of the growth management and natural resources committee, or its successor.
