3 amending Motion 11122, Section G, as amended, and OR
4 2-040 and Motion 11122, Section H, as amended, and OR

7 WHEREAS, Section 270.20 of the King County Charter has been amended to
8 provide that each regional committee shall have nine voting members, three of whom
9 shall be metropolitan county councilmembers appointed by the chair of the council, and
10 shall include councilmembers from districts with unincorporated residents, and

11 WHEREAS, Section 270.20 of the King County Charter has been amended to
12 provide further that the chair of each regional committee shall be a county
13 councilmember appointed by the chair of the county council and that the vice-chair of
14 each regional committee shall be appointed by majority vote of those committee
15 members who are not county councilmembers, in accordance with voting rights that are
16 apportioned as provided in that section, and

17 WHEREAS, the December 5, 2008, effective date of the charter amendment
18 precedes the council's adoption of its 2009 organizational motion, making necessary an
19 interim amendment of the council's organizational rules in order to comply with the
20 charter amendment;

21 NOW, THEREFORE, BE IT MOVED by the Council of King County:

22 I. Motion 11122, Section G, as amended, and OR 2-040 are each hereby amended
23 to read as follows:

24 **OR 2-040. Chairs and vice-chairs.** The council designates the following


