1 A MOTION authorizing temporary free disposal of flood-
2 related debris resulting from the January 2009 flood event.

4 WHEREAS, King County experienced unusually destructive rain, flooding and
5 other secondary hazards ("flood") beginning early January 2009, causing significant
6 damage to homes and other property, and

7 WHEREAS, the executive, on January 8, 2009, declared a flood emergency for
8 King County, and

9 WHEREAS, disposal of solid waste material resulting from the flood at normal
10 disposal fees would cause financial hardship for many property owners and could delay
11 the cleanup of debris, and

12 WHEREAS, all of King County will benefit from the prompt cleanup of debris
13 caused by the flood, and

14 WHEREAS, the executive, on January 8, 2009, called for a temporary waiver of
15 solid waste fees for the disposal of flood-related debris at county disposal sites beginning
16 January 10, 2009, ending January 26, 2009, and

17 WHEREAS, pursuant to K.C.C. 10.12.050.B, actions taken by the executive to

18 temporarily waive solid waste disposal fees that continue beyond the date of the next
19 regularly scheduled council meeting require council approval by motion, and

20 WHEREAS, the estimated loss of revenue resulting from the temporary solid
21 waste disposal fee waiver is approximately \$100,000, and

22 WHEREAS, the executive reserves the option to return to the council with a
23 detailed accounting of the actual revenue lost and related expenses incurred as a result of
24 the temporary solid waste disposal fee waiver for the purpose of obtaining a
25 supplemental appropriation;

26 NOW, THEREFORE, BE IT MOVED by the Council of King County:

27 A. The King County council hereby authorizes the executive to temporarily
28 suspend solid waste disposal fees for flood-related debris related to damage from the
29 flood of January 2009;

30 B. Loads of flood-related debris from commercial haulers will not be accepted at
31 no charge without prior authorization by the division director of the King County solid
32 waste division;

33 C. This temporary fee suspension is only authorized from January 10, 2009
34 through January 26, 2009; and

35 D. The following special conditions apply to the temporary suspension of the
36 disposal fee for flood-related debris:

37 1. All King County residents are eligible, except those who live in the cities of
38 Seattle and Milton, which are not part of King County's solid waste handling system;

39 2. King County residents must provide acceptable proof of residence such as a
40 current utility bill or other piece of mail containing the resident's current address;

- 41 3. All loads must be properly secured; unsecured loads will be subject to
42 unsecured load fees per K.C.C. 10.12.040;
- 43 4. Loads of flood-related debris may be inspected by King County solid waste
44 division staff, and division staff reserve the right to limit quantities disposed without
45 charge;
- 46 5. Only flood-related debris may be disposed at no charge; split loads of mixed
47 flood-related debris and regular solid waste will be charged at the regular solid waste
48 disposal rate;
- 49 6. All standard King County waste acceptance policies apply (see K.C.C. Title
50 10 and King County Public Rules and Regulations: Waste Acceptance Rule for King
51 County Solid Waste Division Solid Waste Handling Facilities
52 <http://www.metrokc.gov/recelec/archives/policies/put715pr.htm>); and
- 53 7. Eligibility to participate in this emergency flood-debris disposal opportunity

55 is conditioned upon strict compliance with the solid waste handling procedures provided
56 by the King County solid waste division.


