1 A MOTION related to the transfer of retired vanpool vans
2 to nonprofit organizations and local governments to meet
3 the needs of low-income, elderly, disabled and young
4 county citizens.

6 WHEREAS, King County provides transit services to its citizens to increase
7 mobility options and reduce traffic congestion and related environmental degradation,
8 and

9 WHEREAS, the provision of passenger vans to groups serving individuals with
10 limited resources and mobility options will support those goals and provide significant
11 public benefits, and

12 WHEREAS, high-quality passenger vans retaining substantial value and utility
13 are periodically retired from the county's vanpool program, and

14 WHEREAS, the metropolitan King County council has previously transferred
15 retired vans to agencies serving low-income, elderly, disabled and young people, and

16 WHEREAS, K.C.C. 4.56.100 states that "each year the transit division shall make
17 available retired passenger vans for exclusive use by nonprofit organizations or local

18 governments that are able to address the mobility needs of low-income, elderly or young
19 people or people with disabilities";

20 NOW, THEREFORE, BE IT MOVED by the Council of King County:


