13 NOW, THEREFORE, BE IT MOVED by the King County Council:


14 The manager of treasury operations of King County is hereby authorized to cancel

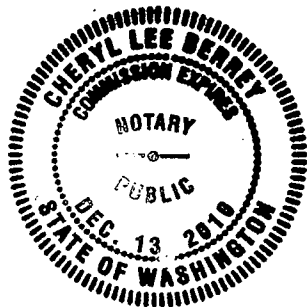
