1 A MOTION relating to the organization of the council;
2 amending Motion 10651, Section II, and OR 1-010, Motion
3 10651, Section IV, as amended, and OR 1-030, Motion
4 11105 (part), as amended, and OR 1-040 and Motion
5 11122, Section G, as amended, and OR 2-040.

6 WHEREAS, the council has specified by motion the chairs, vice-chairs and
7 members of council committees and provided for any changes to these positions to be
8 made by adoption of a formal legislative motion, and

9 WHEREAS, the council desires to specify vice-chairs and committee chairs and
10 vice-chairs;

11 NOW, THEREFORE, BE IT MOVED by the Council of King County:

12 I. Motion 10651, Section II, and OR 1-010 are each hereby amended to read as
13 follows:

14 A. The council shall elect a chair and vice-chairs, who shall serve at the pleasure
15 of the council for a term of one year, unless decided otherwise by the council and until
16 successors are elected.

17 B. There shall be two vice-chairs: the vice-chair of policy development and
18 review and the vice-chair of regional coordination. For the purposes of implementing
19 K.C.C. chapter 1.24, "vice-chair" means the vice-chair of policy development and review.

20 In the absence of the vice-chair of policy and development review, "vice-chair" means
21 the vice-chair of regional coordination.

22 C. In the event the chair is unable to serve the remainder of a term, the vice-chair
23 shall become chair, consistent with the order in subsection B. of this section. In the event
24 the vice-chair is unable to serve the remainder of a term, a new vice-chair shall be
25 elected.

26 II. Motion 10651, Section IV, as amended, and OR 1-030 are each hereby
27 amended to read as follows:

28 A. The vice-chairs shall exercise the duties, powers and prerogatives of the
29 council chair in the event of the chair's absence, consistent with the order in OR 1-010.B.

30 B. The vice-chair of policy development and review shall serve as the chair of the
31 committee of the whole.

32 C. The vice-chair of regional coordination shall preside during the portion of a
33 committee of the whole meeting that is considering the Eastside Rail Corridor.

34 III. Motion 11105 (part), as amended, and OR 1-040 are each hereby amended to
35 read as follows:

36 For the year ~~((2012))~~ 2013, and until a successor is elected, the council elects
37 Councilmember Larry Gossett as council chair, Councilmember Julia Patterson as
38 council vice-chair of policy development and review and Councilmember Jane Hague as
39 council vice-chair of regional coordination.

40 IV. Motion 11122, Section G, as amended, and OR 2-040 are each hereby
41 amended to read as follows:

42 The council designates the following councilmembers as chairs and vice-chairs of
43 the standing committees created in this motion and the regional committees established in
44 the King County Charter.




