1	A MOTION appointing a committee to write the voters'
2	pamphlet statement for the November 5, 2013, general
3	election regarding Ordinance 17598 providing for the
4	submission to the qualified electors of King County at a
5	general election to be held in King County on November 5,
6	2013, of a proposition authorizing the continuation of a
7	property tax levy in under chapter 84.52 RCW, for an
8	additional six-consecutive-year period, at a rate of not more
9	than \$0.335 per one thousand dollars of assessed valuation,
10	for the purpose of paying for the continued operation of the
11	Medic One/Emergency Medical Services system.
12	WHEREAS, K.C.C. chapter 1.10 provides for the publication and distribution of
13	local voters' pamphlets in conformity with chapter 29A.32 RCW for annual general
14	elections held in King County, and
15	WHEREAS, RCW 29A.32.280 provides that, for each measure from a unit of
16	local government that is included in a local voters' pamphlet, the legislative authority of
17	that jurisdiction shall formally appoint a committee to prepare arguments advocating
18	voter approval of the measure and a committee to prepare arguments advocating voter
19	rejection of the measure, and

20	WHEREAS, Ordinance 17598 provides for the submission to the qualified
21	electors of King County at a general election to be held in King County on November 5,
22	2013, of a proposition authorizing the continuation of a property tax levy under chapter
23	84.52 RCW, for an additional six-consecutive-year period, at a rate of not more than
24	\$0.335 per one thousand dollars of assessed valuation, for the purpose of paying for the
25	continued operation of the Medic One/Emergency Medical Services system;
