	Proposed No. 2015-0529.1 Sponsors McDermott and Dembowski
1	A MOTION declaring the county's intent to establish a
2	grant program to support mentoring services for youth.
3	WHEREAS, in January 2014, Ordinance 17738 created a youth action plan task
4	force to develop a proposed youth action plan to provide a policy basis for the
5	development and implementation of King County policies and programs involving youth
6	and
7	WHEREAS, in April 2015, the youth action plan task force report included
8	recommendations in nine areas, including social justice and equity and stopping the
9	school to prison pipeline, and
10	WHEREAS, recommendations related to social justice and equity addressed the
11	need for King County to prioritize and provide resources to recognize, prevent and
12	eliminate institutional racism and other forms of bias across county government, and
13	WHEREAS, recommendations related to stopping the school to prison pipeline
14	called on the county and its partners to support preventative practices and programs that
15	reduce the likelihood of contact with the juvenile justice system, and
16	WHEREAS, in June 2015, the council passed Motion 14378, adopting the youth
17	action plan task force recommendations, and

18	WHEREAS, in July 2015, Ordinance 18088 placed on the ballot the best starts for
19	kids property tax levy to fund prevention and early intervention strategies to improve the
20	health and well-being of children, youth and their communities, and
21	WHEREAS, in November 2015, King County voters approved the best starts for
22	kids property tax levy, and
23	WHEREAS, best starts for kids property tax levy proceeds will become available
24	in late 2016 following council approval of an implementation plan that takes into
25	consideration the county's youth action plan and any recommendations of the county's
26	juvenile justice equity steering committee that was formed in 2015 to address
27	disproportionality in the juvenile justice system that are adopted into policy, and
28	WHEREAS, a 2002 report prepared for the Edna McConnell Clark Foundation
29	found that mentorship programs have been linked to socio-emotional development
30	benefits among youth, including improvements in parental relationships, educational
31	engagement and attendance, as well as decreased likelihood of risky behaviors such as
32	illegal drug and alcohol use and violent behaviors, and
33	WHEREAS, in the near term, the council wishes to invest in targeted mentorship
34	programs for youth in 2016 before best starts for kids levy proceeds become available;
35	NOW, THEREFORE, BE IT MOVED by the Council of King County:
36	A. It is the intent of the council to appropriate one hundred thousand dollars in
37	2016 to the department of community and human services to administer a competitive
38	grant program to support mentorship services for youth.

39	B. The department of community and human services is requsted to issue a
40	request for proposals and is requested to evaluate proposals and award funds based on the
41	following criteria:
42	1. Potential impact to reduce inequities that result in disparate outcomes in
43	juvenile justice;
44	2. Potential ability to engage at-risk gang and justice involved populations with
45	efforts geared to prevention, reengaging or reconnecting this population;
46	3. Potential impact to improve social justice and equity;
47	4. Potential impact of disrupting the school to prison pipeline;
48	5. Evidence of ability to provide culturally competent services, if applicable,
49	including quality intepretation services;
50	6. Ability to use grant funds for service delivery with minimal time and cost
51	needed for implementation;
52	7. Evidence of past success or strong ablity to achieve performance outcomes
53	related to the above citeria; and
