## Metropolitan King County Council Government Accountability and Oversight Committee 2017 Work Program

The Government Accountability and Oversight Committee will consider and make recommendations on:

- Improving the efficiency, cost effectiveness, and performance of all branches of County government;
- Enhancing oversight, accountability, and transparency in County government; and
- Increasing general government oversight.

During 2017, the Committee will focus on the following issues:

1. Technology Oversight and Monitoring. Review activities, reports, policy proposals, and plans for King County's use of technology to improve delivery of public services.

#### Key Work Program Items:

- Review and make recommendations to the full Council on Review annual update to the County's Strategic Technology Plan
- Review Benefit Achievement Plans for proposed and ongoing IT projects
- Track and report on any related budgets, provisos and responses
- 2. **Human Resources Oversight.** Review and make recommendations to the full Council on issues related to King County employees and human resources issues.

### Key Work Program Items:

- Review proposed collective bargaining agreements with labor units that are within the committee's jurisdiction
- Receive briefings and review legislation on human resources policy and initiatives, such as leave policies, recruitment, worker safety, voluntary separation, and training
- Track and report on any related budgets, provisos and responses, including the proviso response related to accountable care networks (Ordinance 18409, Section 121, Proviso P1
- **3. King County Auditor's Office.** Review the work of the King County Auditor as outlined in Motion 14802, adopting the King County Auditor's Office 2017-18 Work Program.

### Key Work Program Items:

• Receive briefings on a range of Auditor's Office work items and consider legislative action based on presented findings, including

 A performance audit of overtime in the King County Sheriff's Office
 An evaluation of the roles, responsibilities and general effectiveness among different stakeholders in addressing homelessness
 An assessment of Real Estate Services' processes for tax title properties
 Continued oversight of projects in the King County Courthouse

- Receive updates on the County's Capital Project Oversight Program
- Track and report on any related budgets, provisos and responses, including
  - a performance audit of the department of permitting and environmental review's workload and staff to determine if the department is providing services and processing permits efficiently and economically (Ordinance 18409, Section 10, Expenditure Restriction ER1); and
  - a performance audit of the community based relicensing program operated by Legacy of Equality, Leadership and Organizing ("LELO") under contract with King County (Ordinance 18409, Section 10, Expenditure Restriction ER2).
- **4. Elections Oversight.** Review and make recommendations to the full Council on Elections operations.

- Consider appointments to Citizens' Elections Oversight Committee
- Review Citizens' Elections Oversight Committee 2017 Annual Report with briefing from CEOC Chair
- Review and discuss goals, accomplishments and proposed innovations with Elections Director
- Track and report on any related budgets, provisos and responses
- **5.** Taxi, Car Sharing and For-Hire Oversight. Review and make recommendations to the full Council on taxicab, ride sharing and for-hire services.

- Review the annual Taxicab Report
- Briefing on the state legislature's actions related to the for-hire industry
- 6. King County Airport. Review and make recommendations to the full Council on operations and future planning for the King County Airport.
