8	WHER	EAS, the King County executive	on June 19, 2017, issued an Executive
9	Determination	of Emergency, declaring that imp	mediate steps must be taken to design,

11	WHER	EAS, in accordance with K.C.C.	2.93.080, the Executive Determination of
12	Emergency was	ived the competitive procuremen	t requirements of state and county law,
13	stating in releva	ant part as follows:

20	continue in full force and effect until all necessary contracts are executed, or until
21	terminated by subsequent order of the King County executive, action by the metropolitan
22	King County council by ordinance, or as otherwise may be required by law," and
23	WHEREAS, under K.C.C. 2.93.080.B., such a waiver stays in effect until
24	terminated by order of the executive, or action of the council by ordinance, or until it
25	expires, which is ten days after there have been contracts entered into, which combined,
26	encumber funds in excess of two-hundred-fifty-thousand dollars or in excess of
27	appropriation, unless the council extends the waiver by motion beyond the ten-day
28	period, and

40	three-hundred-foot-long steel trussed spans, a short approach span on the west side and
41	three one-hundred-twenty-foot-long concrete girder spans on the east side of the river.
42	The bridge has two travel lanes and two shoulders, and
43	WHEREAS, following the 2007 collapse of the eight-lane bridge on Interstate
44	35W in Minnesota, and the federal decision to allow heavier trucks on roadways, the
45	Federal Highway Administration ("FHWA") developed new requirements for bridge load
46	ratings, and
47	WHEREAS, the Washington state Department of Transportation ("WSDOT") is
48	responsible for enforcing implementation of the new FHWA criteria for load ratings by
49	local government agencies; and
50	WHEREAS, FHWA and WSDOT require all bridges to be evaluated by 2022
51	using the new criteria, and
52	WHEREAS, as part of the new criteria, agencies are required to review gusset
53	plate connections, which are thick sheets of steel bolting together structural elements of
54	truss bridges. There are about thirty-six thousand bolts fastening the plates on the two
55	three-hundred-foot-long steel trusses of the bridge, and
56	WHEREAS, the King County department of transportation has a bridge structural
57	engineer who calculates bridge load ratings using specialized software, and
58	WHEREAS, in the spring of 2017, the King County department of transportation
59	bridge structural engineer visually inspected the bridge and recalculated the bridge load
60	ratings based on the new federal criteria, and

61	WHEREAS, although no signs of cracking at the gusset plate connections was
62	observed, the recalculation revealed serious questions about the structural integrity of the
63	bridge, and
64	WHEREAS, the county hired an independent structural engineering firm to
65	review the King County department of transportation bridge structural engineer's
66	recalculation of the bridge load ratings for the bridge, and
67	WHEREAS, the independent structural engineering firm confirmed the King
68	County department of transportation bridge structural engineer's recalculation of the
69	bridge load ratings for the bridge and brought to light further concerns regarding the
70	structural integrity of the bridge, and
71	WHEREAS, on June 16, 2017, the county reviewed the structural engineering
72	firm's determinations with the WSDOT engineers and they concurred that the county and
73	its consultants had appropriately applied the new criteria, and
74	WHEREAS, the average daily traffic of this bridge is approximately three
75	thousand vehicle trips, and
76	WHEREAS, motorists with vehicles over the six ton posted load restriction will
77	be forced to take detours of approximately twelve miles, depending upon the route, due to
78	the bridge posted restriction, and
79	WHEREAS, repairs are complex, will require special expertise to resolve and will
80	take time to design and implement, and
81	WHEREAS, closure of the bridge will impact individuals and nearby

82	communities by reducing access to transportation networks, schools and first responder
83	services, and by potentially isolating residents during storm and flooding events, and
84	WHEREAS, the bridge structural integrity issues revealed by the county's review
85	under the federally mandated load rating criteria, and the ensuing posted load restriction
86	of the bridge to protect the lives and safety of King County residents, constitutes an
87	unforeseen circumstance beyond the county's control that presents a real and immediate
88	threat to the proper performance of an essential government facility, and will likely result
89	in material loss or damage to property unless expeditious action is taken to repair the
90	bridge, and
91	WHEREAS, an emergency waiver of competitive bidding and formal solicitation
92	requirements of state and county law is necessary to assure the timely procurement of
93	design, construction and other required services, materials and equipment necessary to
94	prevent delay in completing the repair of the damaged portions of the bridge, and
95	WHEREAS, this emergency waiver will allow King County to contract for
96	expedited replacement of the damaged portions of the bridge, and
97	WHEREAS, the executive intends to negotiate and execute one or more
98	additional contracts to either repair or replace, or both, the damaged structures of the
99	bridge, and
100	WHEREAS, an extension of the waiver from the competitive procurement
101	requirements of state and county law is necessary at this time because the magnitude of
102	the expenses to be incurred will almost immediately exceed the two-hundred-fifty-

103 thousand-dollar limit, and 104 WHEREAS, the facts set forth in these clauses and in the executive's Determination of Emergency and Waiver establish an emergency as defined by K.C.C. 105 2.93.080 and RCW 39.04.280, and 106 WHEREAS, the county intends that to the fullest extent feasible all contracts and 107 agreements entered into in accordance with the waiver extended by this motion will 108 include all of the county procurement requirements, including, but not limited to, K.C.C. 109 chapters 4.04, 2.93, 12.16 and 12.18, K.C.C. 4A.100.070 and all applicable King County 110 111 executive policies and procedures, waived by the executive in the Executive Determination of Emergency issued on June 19, 2017, and 112 WHEREAS, by the King County Code, the council has the authority to terminate 113 waivers by ordinance; 114 115 NOW, THEREFORE, BE IT MOVED by the Council of King County: A. The June 19, 2017, Determination of Emergency and Waiver of competitive 116 117 bidding and formal solicitation requirements for the lease or purchase of tangible personal property or services, public works as defined by RCW 39.04.010, or to the 118 119 selection and award of either and professional or technical consultant services under state 120 law and K.C.C. chapter 2.93 is extended through December 31, 2018, in order to 121 complete either the repair or the replacement, or both, of damaged portions of the bridge. 122 B. The extension of the waiver of competitive bidding and formal solicitation requirements included in section A. of this motion are contingent upon the following: 123

124	1. The executive filing status reports on the ongoing repair work quarterly with
125	each report filed no later than forty-five days after the close of a fiscal quarter, so that the
126	first report shall be filed no later than April 13, 2018. The reports shall include at a
127	minimum:
128	a. expenditures during the previous quarter and anticipated for the next quarter;
129	b. project expenditures to date;
130	c. a current estimate of the total costs of the repairs;
131	d. a list of the contracts or agreements undertaken under the authority in this
132	waiver, including for each contract or agreement: the name of the vendor, the type of
133	work, the value of the contract or agreement and the level of compliance with the
134	contracting requirements of K.C.C. 3.15.100, K.C.C. chapters 12.16, 12.17, 12.18 and
135	12.19 and related administrative rules;
136	e. a summary of procurement actions anticipated, but not yet undertaken under
137	the authority of this procurement waiver; and
138	f. a discussion of specific actions taken during the previous quarter to continue
139	to obtain competitive prices on behalf of the rate payers despite this waiver, including but
140	not limited to procurements let or to be let in accordance with the requirements of K.C.C.
141	chapters 2.93 and achieving compliance with K.C.C. 3.15.100, K.C.C. chapters 12.16,
142	12.17, 12.18 and 12.19 and related administrative rules; and
143	2. The reports required under this section B. shall be filed in the form of a paper
144	original and an electronic copy with the clerk of the council who shall retain the original

and provide a copy to all councilmembers, the council chief of staff, the chief policy

147 officer, the lead staff for the transportation, environment and economy committee, or its

148 successor, the budget and fiscal management committee, or its successor, and the

149 regional water quality committee, or its successor.
