1 A MOTION confirming the appointment of Jeffrey Manson
2 to the citizens' elections oversight committee as the
3 representative of the King County Democratic Party.

4 WHEREAS, the King County Democratic Party has identified Jeffrey Manson to
5 represent the organization on the citizens' election oversight committee, and

6 WHEREAS, King County is committed to conducting open, accurate and fair
7 elections, and

8 WHEREAS, the citizens' election oversight committee help to ensure that
9 accountability and performance of the elections division is provided in a transparent
10 manner that is meaningful to King County residents, and

11 WHEREAS, fifteen of the sixteen positions on the citizens' election oversight
12 committee are currently vacant, and

13 WHEREAS, in accordance with K.C.C. 2.53.021, King County council is tasked
14 with appointing new members of the citizens' election oversight committee, and

15 WHEREAS, in accordance with K.C.C. 2.28.010, when the King County council
16 recreates a board with more than nine members, the appointed terms are staggered: one-
17 fourth for one year, one-fourth for two years, one-fourth for three years or the full term if
18 the full term is three years, and one-fourth for full terms, and

19 WHEREAS, in accordance with K.C.C. 2.53.021, the employment and

20 administration committee of the King County council appointed Jeffrey Manson on July
21 15, 2019;

22 NOW, THEREFORE, BE IT MOVED by the Council of King County:

23 The appointment of Jeffrey Manson to serve on the citizens' elections oversight

24 committee as a representative of the King County Democratic Party for a two-year
25 staggered term ending July 2021 is hereby confirmed.
