1 A MOTION confirming the appointment of Allison Feher
2 to the citizens' elections oversight committee as the
3 representative from a nonpartisan organization active in
4 King County that provides elections information to the
5 public, such as the League of Women Voters.

6 WHEREAS, the League of Women Voters of Seattle-King County has identified
7 Allison Feher to represent the organization on the citizens' election oversight committee,
8 and

9 WHEREAS, King County is committed to conducting open, accurate and fair
10 elections, and

11 WHEREAS, the citizens' election oversight committee help to ensure that
12 accountability and performance of the elections division is provided in a transparent
13 manner that is meaningful to King County residents, and

14 WHEREAS, fifteen of the sixteen positions on the citizens' election oversight
15 committee are currently vacant, and

16 WHEREAS, in accordance with K.C.C. 2.53.021, King County council is tasked
17 with appointing new members of the citizens' election oversight committee, and

18 WHEREAS, in accordance with K.C.C. 2.28.010, when the King County council
19 recreates a board with more than nine members, the appointed terms are staggered: one-

20 fourth for one year, one-fourth for two years, one-fourth for three years or the full term if
21 the full term is three years, and one-fourth for full terms, and

22 WHEREAS, in accordance with K.C.C. 2.53.021, the employment and
23 administration committee of the King County council appointed Allison Feher on July
24 15, 2019;

25 NOW, THEREFORE, BE IT MOVED by the Council of King County:

26 The appointment of Allison Feher to serve on the citizens' elections oversight

27 committee as a representative of the League of Women Voters for a three-year staggered
28 term ending July 2022 is hereby confirmed.
