1                   A MOTION proposing an honorary road name designation  
2                   in recognition of Mukai Farm & Garden.

3                   WHEREAS, the council, by motion, may propose an honorary road name  
4 designation, consistent with K.C.C. 16.08.060, and

5                   WHEREAS, the Mukai Farm & Garden is one of the only extant examples of a  
6 pre-World War Two Japanese American farmstead in America, and

7                   WHEREAS, before World War Two, the Mukai Farm & Garden was one of the  
8 largest strawberry farms in America, and

9                   WHEREAS, the farmstead was once a hub of Japanese American social and  
10 cultural life on Vashon Island, and

11                   WHEREAS, the Mukai Agricultural Complex was designated a King County  
12 Landmark in 1993, and

13                   WHEREAS, its garden, designed by Kuni Mukai in 1932, is the first Japanese-  
14 inspired stroll garden in the United States designed by an Issei woman, and

15                   WHEREAS, Kuni's Garden received the 2020 John Spellman award for garden  
16 restoration, and

17                   WHEREAS, the Mukai Cold Process Barreling Plans played a significant role in  
18 developing innovative processing and canning practices that helped revolutionize the fruit  
19 business in the United States, and

20 WHEREAS, the Mukai Farm & Garden symbolizes the vibrant role of Japanese  
21 Americans in Vashon's pre-World War Two agricultural economy, and

22 WHEREAS, the Mukai Farm & Garden continues to educate and engage the  
23 people of King County about Asian American history and cultures;

24 NOW, THEREFORE, BE IT MOVED by the Council of King County:

25 A. The council proposes that the section of 107th Avenue SW from SW Bank Rd  
26 south to terminus of the road be given the honorary road name designation "Mukai Way"  
27 to honor the contributions of the Mukai family and the broader Japanese American  
28 immigrant community to 20th-century agriculture, business and community life on  
29 Vashon Island.

30 B. In accordance with K.C.C. 16.08.060.C.5., the road services division is  
31 directed to prepare a list of the names and addresses of all affected property owners on  
32 107th Avenue SW from SW Bank Rd south to terminus of the road. The list shall be sent  
33 electronically to the clerk of the council no later than April 20, 2021, who shall provide  
34 an electronic copy to all councilmembers, the council chief of staff, the policy staff  
35 director and the lead staff of the local services committee, or its successor.

36 C. Within ten days of receipt of the list of affected property owners, from the  
37 road services division, the clerk of the council shall mail to each affected property owner  
38 a copy of this motion and a notice advising the affected property owners that the council  
39 may introduce an ordinance to make the honorary road name designation. The notice  
40 shall inform the affected property owners that the proposed honorary name designation  
41 will not replace the legal name of the street or change their addresses, and that the costs  
42 associated with installing and maintaining the honorary road name designation signage

43 shall be borne by the road services division or its successor. The notice shall provide that  
44 members of the public may submit comments on the proposed honorary name  
45 designation to the clerk of the council no later than May 30, 2021, and shall include both  
46 email and regular postal mail addresses to which comments may be submitted. The clerk  
47 of the council shall retain any submitted comments and provide, by June 11, 2021, copies

48 of submitted comments to all councilmembers, the council chief of staff, the policy staff  
49 director and the lead staff for the local services committee, or its successor.
