2           pamphlet statement for the August 3, 2021, special election

3           regarding Ordinance 19267 providing for the submission to

4           the qualified electors of King County at a special election

5           to be held in King County, on August 3, 2021, of a

6           proposition providing for resident oversight and authorizing

7           a property tax levy in excess of the levy limitation

8           contained in chapter 84.55 RCW for a six-year consecutive

9           period at a rate of not more than \$0.19 per one thousand

10          dollars of assessed valuation in the first year, and limiting

11          annual levy increases to three percent in the five

12          succeeding years, all for the purpose of funding prevention

13          and early intervention strategies and a capital grants

14          program to improve the health and well-being of children,

15          youth and their communities.

16           WHEREAS, K.C.C. chapter 1.10 provides for the publication and distribution of

17   local voters' pamphlets in conformity with chapter 29A.32 RCW for elections held in

18   King County, and

19           WHEREAS, RCW 29A.32.280 provides that for each measure from a jurisdiction

20 that is included in a local voters' pamphlet, the legislative authority of that jurisdiction  
21 shall formally appoint a committee to prepare arguments advocating voter approval of the  
22 measure and a committee to prepare arguments advocating voter rejection of the measure,

24 WHEREAS, Ordinance 19267 provides for submission to the qualified electors of  
25 King County at a special election to be held on August 3, 2021, a proposed property tax  
26 levy for the purpose of funding prevention and early intervention strategies and a capital  
27 grants program to improve the health and well-being of children, youth and their  
28 communities;
