1 A MOTION making an appointment to fill a judicial
2 vacancy in the west division, west electoral district, judge
3 position number two of the King County district court.

4 WHEREAS, a judicial vacancy exists in the west division, west electoral district,
5 judge position number two of the King County district court, and

6 WHEREAS, RCW 3.34.100 authorizes the county legislative body to fill judicial
7 vacancies in district court, and

8 WHEREAS, K.C.C. chapter 2.70 provides for the metropolitan King County
9 council to fill judicial vacancies in district court, and

10 WHEREAS, in accordance with K.C.C. 2.70.020.D., candidates must have a
11 current rating of, at a minimum, "qualified" for a district court judicial position from the
12 King County Bar Association and at least one other bar association operating in King
13 County with an eligible judicial candidate evaluation process, and

14 WHEREAS, a rating of the Seattle King County Bar Association is valid for three
15 years, and

16 WHEREAS, for those eligible candidates, the committee of the whole reviewed
17 candidate ratings from the Seattle King County Bar Association and other bar
18 associations with an established judicial candidate evaluation procedure, reviewed written
19 materials concerning each candidate and conducted interviews with the final candidates

21 WHEREAS, the council has carefully considered the qualifications of the final
22 candidates;


