5 court judge of the county, and

6 WHEREAS, the King County council has used the authority provided in RCW
7 36.32.200 to hire legal counsel to provide the council with legal advice on legislative,
8 contractual and other legal matters, and

9 WHEREAS, Monique Cohen was originally appointed to the position of the chief
10 legal counsel to the King County council for a two-year term effective November 18,
11 2019, through November 19, 2021, and

12 WHEREAS, the council wishes to reappoint Monique Cohen to serve an
13 additional two-year term in the position of chief legal counsel to the King County
14 council;

15 NOW, THEREFORE, BE IT MOVED by the Council of King County:

16 The chair of the employment and administration committee is authorized to sign a
17 contract letter that is substantially similar to Attachment A to this motion appointing
