**Proposed No.** 2021-0333.1 **Sponsors** Kohl-Welles 1 A MOTION adopting an updated Debt Management Policy 2 for King County; and rescinding Motion 12660. 3 WHEREAS, King County is one of the largest issuers of municipal bonds in the 4 nation and has a long history of achieving exemplary credit ratings, in part because of 5 sound financial management and debt issuance practices, and 6 WHEREAS, RCW 36.48.070 requires the adoption of a debt policy by counties 7 within the state of Washington, and 8 WHEREAS, the credit rating agencies have identified that having an adopted debt 9 policy is a positive factor in their rating of the county, and 10 WHEREAS, the county recognizes the need to have a formal adopted debt 11 management policy to provide guidance on best issuance and post-issuance practices, and 12 WHEREAS, Motion 12660 adopted the current King County Debt Management 13 Policy in 2007, and WHEREAS, Motion 12660 calls for periodic updates of the King County Debt 14 15 Management Policy, and 16 WHEREAS, since 2007, there have been many significant developments in the 17 municipal finance market that are not adequately addressed, if addressed at all, in Motion 18 12660, and 19 WHEREAS, finance division staff has accordingly consulted with the County's 20 financial advisor to draft an updated Debt Management Policy that incorporates

21	appropriate discussion of such subsequent developments, and
22	WHEREAS, the proposed changes are considered to represent "substantive
23	changes" from the current adopted Debt Management Policy, and
24	WHEREAS, pursuant to the direction in the adopted Debt Management Policy,
25	the executive finance committee has reviewed and approved the substantive changes in
26	the updated Debt Management Policy, and
27	WHEREAS, the executive finance committee has recommended the updated Debt
28	Management Policy be forwarded to the Metropolitan King County council for adoption;
