1           A MOTION appointing committees to write the voters'  
2           pamphlet statements for the November 8, 2022, general  
3           election regarding Ordinance 19465 proposing an  
4           amendment to the King County Charter to move elections  
5           for certain county offices from odd-numbered to even-  
6           numbered years; amending Sections 640, 647 and 650.20 of  
7           the King County Charter and repealing Sections 650.40.15,  
8           650.40.25 and 660 of the King County Charter; and  
9           submitting the same to the voters of the county for their  
10          ratification or rejection at the November 8, 2022, general  
11          election.

12          WHEREAS, K.C.C. chapter 1.10 provides for the publication and distribution of  
13          local voters' pamphlets in conformity with chapter 29A.32 RCW for elections held in  
14          King County, and

15          WHEREAS, RCW 29A.32.280 provides for each measure from a jurisdiction that  
16          is included in a local voters' pamphlet, the legislative authority of that jurisdiction shall  
17          formally appoint a committee to prepare arguments advocating voter approval of the  
18          measure and a committee to prepare arguments advocating voter rejection of the measure,

22 elections for certain county offices from odd-numbered to even-numbered years;

24 Sections 650.40.15, 650.40.25 and 660 of the King County Charter; and submitting the  
25 same to the voters of the county for their ratification or rejection at the November 8,  
26 2022, general election;


